Program Narrative:

The City of Lexington proposes to fund a police cruiser for the Lexington Police Department through the Edward Byrne Memorial Justice Assistance Grant FY2009. Our Police Department currently has four police cruisers. Two have over 80,000 miles, one with over 140,000 and one with over 150,000 miles. We constantly have one or two cars that are in the shop for repairs and have to assign more than one officer to a cruiser and are in desperate need of an additional cruiser. Dawson County has officially declined all funds concerning this grant. The additional funds will allow our agency to purchase a police cruiser.

The addition of this police cruiser will allow for the Police Department to better distribute personnel within the City of Lexington. Our community is constantly growing and the Police Department needs the ability to grow with the community.

**INTERLOCAL AGREEMENT
BETWEEN THE CITY OF LEXINGTON, NEBRASKA,
AND COUNTY OF DAWSON, NEBRASKA**

RECOVERY ACT: JUSTICE ASSISTANCE GRANT (JAG) PROGRAM AWARD

This Agreement is made and entered into this 8th day of May, 2009, by and between The COUNTY of DAWSON, acting by and through its governing body, the Commissioners, hereinafter referred to as COUNTY, and the CITY of LEXINGTON, NEBRASKA, acting by and through its governing body, the City Council, hereinafter referred to as CITY, both of DAWSON County, State of NEBRASKA, witnesseth:

WHEREAS, this Agreement is made under the authority of Sections 13-801-13-827 of the Nebraska Revised Statutes, Interlocal Cooperation Act; and

WHEREAS; each governing body, in performing governmental functions or in paying for the performance of governmental functions hereunder, shall make that performance or those payments from current revenues legally available to that party; and

WHEREAS, each governing body finds that the performance of this Agreement is in the best interests of both parties, that the undertaking will benefit the public, and that the division of costs fairly compensates the performing party for the services or functions under this agreement; and

WHEREAS, the CITY agrees to provide the COUNTY \$0 from the JAG award for the N/A Program; and

WHEREAS, the CITY and COUNTY believe it to be in their best interests to reallocate the JAG funds.

NOW THEREFORE, the COUNTY and CITY agree as follows:

Section 1.

CITY agrees to pay COUNTY a total of \$0 of JAG funds.

Section 2.

COUNTY agrees to use \$ N/A for the N/A Program until N/A (date).

Section 3.

Nothing in the performance of this Agreement shall impose any liability for claims against COUNTY other than claims for which liability may be imposed by the Political Subdivisions Tort Claims Act.

Section 4.

Nothing in the performance of this Agreement shall impose any liability for claims against CITY other than claims for which liability may be imposed by the Political Subdivisions Tort Claims Act.

Section 5.

Each party to this agreement will be responsible for its own actions in providing services under this agreement and shall not be liable for any civil liability that may arise from the furnishing of the services by the other party.


Section 6.

The parties to this Agreement do not intend for any third party to obtain a right by virtue of this Agreement.


Section 7.






