
# CDA FIRST ADDITION

A REPLAT OF LOT ONE (1), LOT TWO (2), AND LOT THREE (3), REPLAT OF SOUTHEAST SECOND ADDITION,
BEING A REPLAT OF SOUTHEAST SECOND ADDITION WHICH IS A REPLAT OF LOT 1, SOUTHEAST FIRST ADDITION TO THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA, AND LOTS 2, 3, AND 4, KIRKPATRICK'S THIRD ADDITION TO THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA.



### LEGAL DESCRIPTION

A tract of land being part of the Southwest Quarter of the Southeast Quarter (SW1/4 SE1/4) of Section Seventeen (17), Township Nine (9) North, Range Twenty-one (21) West of the Sixth Principal Meridian, Dawson County, Nebraska, and being Lot One (1) Lot Two (2) and Lot Three (3), Replat Of Southeast Second Addition, being a replat of Southeast Second Addition, which is a replat of Lot 1, Southeast First Addition to the City of Lexington, Dawson County, Nebraska, and Lots 2, 3, 4, Kirkpatrick's Third Addition to the City of Lexington, Dawson County, Nebraska, more particularly described as follows: Beginning at the Northwest Corner of Lot 1, Replat Of Southeast Second Addition and assuming the North line of Lot 1, and the North line of Lot 2, and the North line of Lot 3 of said Replat Of Southeast Second Addition as bearing N 88°51'56" E and all bearings contained herein are relative thereto; thence N 88°51'56" E on the North line of Lot 1, and on the North line of Lot 2, and on the North line of Lot 3 of said Replat Of Southeast Second Addition a distance of 533.87 feet; thence continuing on the Northeasterly line of said Lot 3, Replat Of Southeast Second Addition, S 44°53'32" E a distance of 27.66 feet; thence continuing on the East line of said Lot 3, Replat Of Southeast Second Addition, S 01°21'01" W a distance of 433.32 feet to the Southeast Corner of said Lot 3, Replat Of Southeast Second Addition; thence S 88°51'58" W on the South line of said Lot 3, Replat Of Southeast Second Addition a distance of 201.26 feet to the Southeast Corner of said Lot 2, Replat Of Southeast Second Addition; thence N 88°37'49" W and on the South line of said Lot 2, Replat Of Southeast Second Addition a distance of 290.19 feet to the Southwest Corner of said Lot 2, Replat Of Southeast Second Addition; thence N 02°51'58" E on the Westerly line of said Lot 2, Replat Of Southeast Second Addition a distance of 117.63 feet; thence continuing on the Westerly line of said Lot 2, of Replat Of Southeast Second Addition, N 20°58'19" W a distance of 63.01 feet; thence continuing on the Westerly line of said Lot 2, Replat Of Southeast Second Addition, N 88°37'49" W a distance of 64.87 feet to a point on the East right-of-way line of U.S. Highway No. 283; thence continuing on the Westerly line of said Lot 2, Replat Of Southeast Second Addition and on the East right-of-way line of U.S. Highway No. 283, N 32°01'44" W a distance of 29.95 feet; thence continuing on the Westerly line of said Lot 2, and on the Westerly line of said Lot 1, Replat Of Southeast Second Addition and on the East right-of-way line of U.S. Highway No. 283, N 01°22'11" E a distance of 153.61 feet; thence continuing on the Westerly line of said Lot 1, Replat Of Southeast Second Addition and on the East right-of-way line of U.S. Highway No. 283, S 88°37'49" E a distance of 15.00 feet; thence continuing on the Westerly line of said Lot 1, Replat Of Southeast Second Addition and on the East right-of-way line of U.S. Highway No. 283, N 29°41'25" E a distance of 52.70 feet; thence continuing on the Westerly line of said Lot 1, Replat Of Southeast Second Addition and on the East right-of-way line of U.S. Highway No. 283, N 01°22'11" E a distance of 37.04 feet to the place of beginning.
