On Thursday, March 19th, five bids were received and publicly read aloud at City Hall. Attached is a bid tabulation sheet. The bids are summarized below:

All proposals have been reviewed. One of the Bidders (Paulsen) qualified their bid as excluding the installation of Johnson Air Rotation and confirmed the City's involvement of preparing the building pad. No other qualifications were noted on the bids. The apparent low bidder indicated the work would be completed within a 28-week construction period.

The Opinion of Probable Construction Cost of the Base Bid was \$1,464,575. The low bid from T.L. Sund Constructors is 23.8% below the Engineer's Opinion of Probable Construction Cost. It is therefore recommended the bids be accepted and the contract awarded to T.L. Sund Constructors, Inc. in the amount of \$1,115,139 (including all the alternates), and authorization given to your authorized representative to execute agreements.
