DECLARATION OF DRAINAGE AND UTILITY EASEMENT

THIS DECLARATION is made this ___ day of _____, 2017, by the CITY OF LEXINGTON, NEBRASKA, a Nebraska Municipal Corporation ("Declarant").

RECITALS

- A. Declarant is the fee owner of the real property legally described on **Exhibit A** attached hereto (the "Property").
- B. Declarant desires to declare a utility easement for drainage, and sewer, water, gas and electric service lines over, under and across part of the Property for the benefit of the real property legally described as set forth on **Exhibit A**.

DECLARATION

NOW, THEREFORE, the Declarant hereby declares, imposes upon and makes the Property subject to the following easements and covenants:

- 1. <u>Grant of Utility/Drainage Easements</u>. Declarant hereby declares perpetual, non-exclusive, utility and drainage easement over, under and across that part of the Property, as legally described and depicted on Exhibit B and Exhibit C attached hereto (the "Easement Area").
- 2. Access to Utilities in Easement Area. The grant of the easement shall be for all purposes, including the construction, maintenance, operation, inspection, reconstruction, removal of utilities, and other purposes as may be required by the Declarant.
- 3. <u>Duration</u>. The provisions of this Declaration shall remain in full force and effect until the Declarant agrees in writing to terminate said provisions.
- 4. <u>Severability</u>. Invalidation of any one or more of the provisions of this Declaration by judgment or court order shall not affect any of the other provisions, which shall remain in full force and effect.
- 5. <u>Mode of Enforcement</u>. This Declaration may be enforced by proceedings in law to recover damages or by proceedings in equity to restrain any violation or compel performance.
- 6. <u>Anti-Merger</u>. Notwithstanding the Declarant's ownership of more than one parcel, the easements granted hereunder shall burden and benefit each parcel individually, without merger as a result of common ownership.
- 7. <u>Successors and Assigns</u>. This Declaration shall be binding upon and shall inure to the benefit of the parties hereto and their respective heirs, successors and assigns. This Declaration shall run with the land. This Declaration benefits and burdens the Property.




