





1. Property. The property which SELLER has sold and BUYER has purchased is located at 210 East 6th Street, Lexington, Nebraska, and is legally described as:

Lots 1 and 2, Block 44, in the Original Town of Plum Creek, now City of Lexington, Dawson County,

together with all improvements located on the real estate described above, to include specifically, but without limitation, all tanks, pumps, petroleum dispensing equipment and infrastructure, and all computers, software and other property used in the sale and distribution of petroleum products, display cases, refrigeration units, ice machine, shelving, light fixtures and other fixtures to the real estate not specifically excluded herein.
