An ordinance entitled "AN ORDINANCE TO AMEND SECTION 19-3 OF THE LEXINGTON CITY CODE; TO AMEND THE PERMISSABLE DATES FOR SALE OF FIREWORKS; TO REPEAL ORIGINAL SECTION 19-3, AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was presented for Council consideration. Bernie Valish, a local fireworks retailer, spoke in favor of the ordinance. Fagot noted that the State Legislature recently passed legislation allowing sales during the New Year holiday and municipalities may address the law individually. Following discussion, moved by Salem, seconded by Tomasek, to approve Ordinance No. 2286 on first reading. Roll call. Voting "aye" were Tomasek, Salem, Fagot. Motion carried.

BECA GRANT APPLICATION: Deb Jensen, DAD, requested City support of an application for BECA grant funding to support economic development activities. The City and Dawson County would be collaborating sponsors of the grant with the City being the funding recipient and DAD as the administering agency. Following discussion, moved by Salem, seconded by Tomasek, to approve the BECA application as presented and to authorized the mayor to execute the application documents. Roll call. Voting "aye" were Tomasek, Salem, Fagot. Motion carried.

ORDINANCE:

An ordinance entitled "AN ORDINANCE TO AMEND SECTION 16-86 OF THE LEXINGTON CITY CODE; TO RESTRICT PARKING IN DOWNTOWN LEXINGTON FOR STREET CLEANING PURPOSES; TO REPEAL ORIGINAL SECTION 16-86 AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was presented for Council consideration. Following discussion, moved by Tomasek, seconded by Salem, to approve Ordinance No. 2287 on first reading. Roll call. Voting "aye" were Salem, Tomasek, Fagot. Motion carried.

RESOLUTION:

Resolution No. 2010-23 was presented. Pepplitsch noted the Northwest 3rd Paving project will be completed in the near future and traffic control should be considered. Following discussion, moved by Salem, seconded by Tomasek, to approve Resolution No. 2010-23 as presented. Roll call. Voting "aye" were Tomasek, Salem, Fagot. Motion carried.

RESOLUTION NO. 2010-23

Whereas, Code Section 16-14 gives the City Council authority to revise the location of stop signs by Resolution.

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA AS FOLLOWS:

That the Lexington City Manager is hereby authorized and directed to install stop signs at the intersection of Erie Street and 20th Street, requiring north and south bound traffic to stop at that intersection, and is further directed to place stop signs at the intersection of Erie Street and 18th Street, to stop west bound traffic on 18th Street.
