She outlined proposed improvements to include infrastructure, facades, property acquisition, demolition, and energy efficiency upgrades; and noted that the budget could be amended based upon project needs prior to project implementation. Pepplitsch noted that the City would be required to provide \$112,000 in matching funds, being a mixture of public and private dollars. Following discussion, the public hearing was closed.

ORDINANCE: Ordinance No. 2283 entitled "AN ORDINANCE TO AMEND SECTION 3-6 OF THE LEXINGTON CITY CODE; TO PROVIDE FOR 2:00 A.M CLOSING HOURS FOR SALE OF ALCOHOLIC LIQUOR FOR CONSUMPTION ON THE PREMISES; TO REPEAL ORIGINAL SECTION 3-6, AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH: AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was presented for Council consideration as requested by local business owners. Austin Thornburg, Leo Marin, Juan Rodriguez, and Dale Mooberry spoke in favor of the ordinance as this would provide an increased opportunity for business and additional tax revenue. Victor Diaz distributed statistical information from Project Extra Mile on alcohol use, spoke against the passage of the ordinance, and requested that a sunset clause be considered if the ordinance advances towards approval. Following discussion, the ordinance was read by title and no action was taken by the Council.

- **FRONTIER STREET:** Pepplitsch presented a development agreement with Wal-Mart for proposed street improvements on Frontier Street at the Highway 283 intersection. He explained the conceptual plan includes lane widening, turn radius expansion, and the relocation of traffic signal poles. He noted Wal-Mart agrees to contribute 25% of the cost of the project, up to \$50,000, contingent upon a completion date of October 2011. Following discussion, moved by Miller, seconded by Tomasek, to approve the development agreement and authorize the execution of necessary documents. Roll call. Voting "aye" were Salem, Bennett, Tomasek, Miller, Fagot. Motion carried.
- WATER TOWERS: Pepplitsch presented a proposal from Utility Services Co. Inc. for a maintenance program for the two local water towers. The proposed five year maintenance program includes interior and exterior painting of the towers, biannual cleaning and inspection, riser pipe rehabilitation, and vent cap upgrades. He noted that the program is an option to spread the pending maintenance costs out over five years, rather than having large expenditures over the next two years. Following review of the proposal and discussion, moved by Salem, seconded by Tomasek, to authorize the City Manager to enter into an agreement with Utility Services Co for a water tower maintenance program. Roll call. Voting "aye" were Miller, Bennett, Tomasek, Salem, Fagot. Motion carried.
- **PROGRAM ADMINISTRATOR:** Resolution No. 2010-15 was presented at the request of the Lexington Volunteer Fire Department. Moved by Salem, seconded by Miller, to approve Resolution No. 2010-15 as presented. Roll call. Voting "aye" were Tomasek, Bennett, Miller, Salem, Fagot. Motion carried.
