STREET CLOSING REQUEST: Mike Lonowski requested downtown street closures to hold a car show/fundraising event on Sunday, May 29, 2011. He outlined the request and possible activities for the event. Following discussion, moved by Miller, seconded by Salem, to approve the street closures as requested and direct staff to work with the event organizer on specific details for the event. Roll call. Voting "aye" were Bennett, Tomasek, Salem, Miller, Fagot. Motion

carried.

PUBLIC HEARING:

Mayor Fagot opened a public hearing to discuss an ordinance to amending Chapter 28A of the Lexington City Code related to Flood Plain Zoning. Pepplitsch explained that the language in Chapter 28A is outdated and that the proposed amendments will meet current FEMA standards; as new flood maps will become effective May 3, 2011, the revised standards need to be in place by

that date as well. He noted that the proposed ordinance had gained Planning Commission approval. Following review of the proposed amendments and public comments, the public hearing was closed.

ORDINANCE:

Ordinance No. 2294 entitled "AN ORDINANCE AMENDING CHAPTER 28A OF THE LEXINGTON CITY CODE; TO REPEAL ORIGINAL CHAPTER 28A AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was presented. Moved by Salem, seconded by Miller, to suspend the rules regarding the reading of ordinances on three separate occasions. Roll call. Voting "aye" were Tomasek, Bennett, Miller, Salem, Fagot. Motion carried.

Ordinance No. 2294 was presented on final reading. Moved by Salem, seconded by Tomasek, approve Ordinance No. 2294 on final reading. Roll call. Voting "aye" were Bennett, Miller, Tomasek, Salem, Fagot. Motion carried.

FRONTIER ST/HWY 283:

Dana Daniels reviewed the bid tabulation for the Frontier Street & Hwy 283 Intersection Improvement Project; the apparent low bid was from Paulsen, Inc. in the amount of \$187,594.00. Following discussion and review of the engineering recommendation, moved by Salem, seconded by Tomasek, to award a contract for the project to Paulsen, Inc. and authorized the execution or needed documents. Roll call. Voting "aye" were Bennett, Miller, Tomasek, Salem, Fagot. Motion carried.

RESOLUTION:

Resolution No. 2011-14 was presented. Pepplitsch explained that funds for the Opportunity Center Phase 3 project were anticipated to be borrowed as reflected in the budget for the current fiscal year. He noted that staff solicited loan proposals from the local financial institutions and received the most favorable terms from Home Federal Savings. Following discussion, moved by Salem, seconded by Miller, to approve Resolution No. 2011-14 as presented. Roll call. Voting "aye" were Tomasek, Bennett, Miller, Salem, Fagot. Motion carried.

RESOLUTION 2011-14

A RESOLUTION AUTHORIZING THE CITY OF LEXINGTON TO OBTAIN FINANCING FOR CONSTRUCTION OF IMPROVEMENTS TO THE DAWSON COUNTY OPPORTUNITY CENTER KNOWN AS PHASE III.

WHEREAS, the City of Lexington, Nebraska has entered into contracts for the construction of Phase III improvements: and

WHEREAS, it is necessary and advisable for the City to borrow funds for the payment of such construction; and

WHEREAS, the City is authorized by law to borrow funds to pay the cost of capital improvements.

BE IT THEREFORE RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA as follows:

1. That the City of Lexington, Nebraska is hereby authorized to contract for financing with Home Federal Savings and Loan, Lexington Nebraska. The

loan amount shall not exceed \$900,000.00 for a term of 10 years at an interest rate of 3.72%.

 That Joe Pepplitsch, City Manager, is hereby directed and authorized, on behalf of the City of Lexington, Nebraska to execute all necessary documents.

Burnside reported that Lexington has been named a Tree City for the 14th year and that the Downtown Revitalization study was recently awarded an "Excellence in Planning" award at the Nebraska Planning and Zoning Conference in March.
