LIQUOR LICENSE CHANGE: Derek Mitchell, legal counsel for Rodriguez Restaurante Inc., appeared before Council to request approval of an application for Change of Location for his clients' liquor license. He explained that his client is planning to relocate the Premier Club to a downtown property already owned by them with plans to have food available during daytime hours and alcohol service after 9 p.m. Following discussion, moved by Miller, seconded by Salem, to recommend approval of the application to the Liquor Control Commission. Roll call. Voting "aye" were Tomasek, Salem, Miller, Fagot. Motion carried.

ORDINANCE:

Ordinance No. 2309 entitled "AN ORDINANCE TO AMEND SECTIONS 28-10.5, 28-11.4, 28-19.5 and 28-20.5; TO REPEAL ORIGINAL SECTIONS 28-10.5, 28-11.4, 28-19.5 and 28-20.5, AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM." was presented. Pepplitsch reviewed the revisions to allow the development of trailer (camping) parks as special uses in four zoning classifications. Following discussion, moved by Salem, seconded by Tomasek, to suspend the rules requiring the reading of an ordinance on three separate occasions. Roll call. Voting "aye" were Miller, Tomasek, Salem, Fagot. Motion carried.

Ordinance No. 2309 was presented on Final reading. Moved by Miller, seconded by Salem, to approve Ordinance No. 2309 as presented. Roll call. Voting "aye" were Tomasek, Salem, Miller, Fagot. Motion carried.

AMENDMENT:

Pepplitsch reviewed an amendment to the Downtown Revitalization Guidelines for Building Renovations. He explained that the amendment would include an investment threshold to allow for additional funding assistance on a case-bycase basis. Following discussion, moved by Miller, seconded by Tomasek, to approve an amendment to the Downtown Revitalization Guidelines as presented. Roll call. Voting "ay" were Salem, Tomasek, Miller, Fagot. Motion carried.

FINANCIAL REPORT:

Pepplitsch presented the financial report for November 2011. Following his review, moved by Tomasek, seconded by Salem, to accept the report as presented. Roll call. Voting "aye" were Miller, Salem, Tomasek, Fagot. Motion carried.

PLANNING SESSION: Following discussion on planning session dates, moved by Miller, seconded by

Salem, to schedule a planning session on Saturday, January 14, 2012, time to be determined. Roll call. Voting "aye" were Tomasek, Salem, Miller, Fagot.

Motion carried.

ROUNDTABLE: Pepplitsch noted that he has been in discussions with School staff to

schedule a joint meeting of the School Board and City Council in early January to discuss joint facility projects; he will forward information on the

date.

ADJOURNMENT: There being no further business to come before the Council, Mayor Fagot

declared the meeting adjourned.
