The Deed of Conservation Easement was recorded with the Register of Deeds of Dawson County, Nebraska on January 5, 2011 as Instrument No. 2011-0052.

WHEREAS, Tract 2 Owners now wish to increase the efficiency of the irrigation of the aforereferenced real estate by constructing and operating a center pivot on the same, which center pivot will cross over a portion of the tract owned by Tract 1 Owners and which portion of land is burdened by the aforedescribed Conservation Easement. The legal description of the real estate owned by Tract 1 Owners that will be utilized by Tract 2 Owners for the operation of this center pivot is as follows, to-wit:

WHEREAS, Tract 1 Owners are in agreement with allowing the center pivot Tract 2 Owners wish to install on their real estate to cross over the land referred to hereinabove if the restrictions of irrigating that portion of the real estate are removed and if the aforedescribed conservation easement on that portion of the real estate is released.

WHEREAS, the Central Platte Natural Resources District is willing to remove the restrictions on irrigating a portion of the aforedescribed real estate and referred to herein as Tract 1 in exchange for the transfer of the restrictions of the aforesaid Conservation Easement to the approximate 18.94 acre tract owned by the Owners of Tract 2 and legally described as follows, to-wit:

A tract of land in Section Twenty-Nine (29), Township Nine (9) North, Range Twenty- One (21) West of the Sixth Principal Meridian, Dawson County, Nebraska, more particularly described as follows:

WHEREAS, pursuant to NEB. REV. STAT. §76-2,112 (2009), on May 14, 2013, the City of Lexington forwarded the easement request for the new area to be burdened by a conservation easement referred to herein as Tract 2 to the City of Lexington Planning and Zoning Commission for their review and recommendations regarding the conformity of the proposed acquisition to comprehensive planning for the area; and

WHEREAS, also pursuant to NEB. REV. STAT. §76-2,112 (2009) on May 15, 2013, the City of Lexington Planning and Zoning Commission recommended approval of the new easement on Tract 2 at their regularly scheduled meeting; and

NOW, BE IT RESOLVED by the City of Lexington that the release of the conservation easement on Tract 1 legally described hereinabove and the designated conservation easement on Tract 2 legally described hereinabove and more specifically set forth in the Deed of Conservation Easement attached hereto as Exhibit "A" and incorporated herein by this reference, should be, and hereby are, approved.
