## 18<sup>TH</sup> ST/HEARTLAND RD:

Motion carried.

**INTERLOCAL AGMT:** 

Pepplitsch reviewed a draft interlocal agreement with the Lexington School District for a School Resource Officer. Following discussion, moved by Miller, seconded by Vivas, to authorize the City Manager to negotiate and enter into agreement with the Lexington School District for an SRO. Roll call. Voting "aye" were Salem, Vivas, Miller, Fagot. Motion carried.

**ACCOUNTS RECEIVABLE:** 

Pepplitsch reviewed delinquent utility accounts that have been deemed uncollectible. Following discussion, moved by Salem, seconded by Miller, to authorize Staff to remove balances for utility accounts as presented. Roll call. Voting "aye" were Vivas, Salem, Miller, Fagot. Motion carried.

**BUDGET HEARING:** 

Mayor Fagot opened a public hearing to discuss the proposed FY 2014 budget. Council and Staff reviewed the proposed budget. Being no further comments, the public hearing was closed.

**RESTRICTED FUNDS:** 

Pepplitsch reviewed the restricted funds authority. Following discussion, moved by Miller, seconded by Salem, to increase the base of restricted funds by an additional 1% for FY 2014. Roll call. Voting "aye" were Vivas, Salem, Miller, Fagot. Motion carried.

TAX REQUEST HEARING:

Mayor Fagot opened a public hearing to discuss setting the FY 2014 final tax request at a different amount than the prior year request. Following discussion, the public hearing was closed. Resolution No. 2013-27 was presented. Moved by Salem, seconded by Miller, to approve Resolution No. 2013-27. Roll call. Voting "aye" were Vivas, Miller, Salem, Fagot. Motion carried.

### **RESOLUTION NO. 2013-27**

# A RESOLUTION SETTING THE PROPERTY TAX REQUEST FOR FISCAL YEAR 2013-2014 AT A DIFFERENT AMOUNT THAN THE PRIOR YEAR REQUEST.

WHEREAS, Nebraska Revised Statute 77-1601.02 provides that the property tax request for the prior year shall be the property tax request for the current year for purposes of the levy set by the County Board of Equalization unless the Governing Body of the city of Lexington passes by a majority vote a resolution or ordinance setting the tax request at a different amount; and

WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request; and

WHEREAS, it is in the best interests of the Municipality that the property tax request for the current year be a different amount than the property tax request for the prior year.

NOW, THEREFORE, the Governing Body of the city of Lexington by a majority vote resolves that:

1. The 2013-2014 property tax request is set at \$988,167.86.

2. A copy of this resolution shall be certified and forwarded to the County Clerk prior to October 13, 2013.
