A Work Session of the Lexington City Council was held Saturday, October 4, 2014, at the Lexington City Hall, located at 406 East 7th Street, Lexington, Nebraska at 8:00 a.m. Members of the Council present were John Fagot, John Salem, Linda Miller, Dora Vivas and Jeremy Roberts. City Officials present were City Manager Joe Peplitsch, Finance Director Barb Hodges and Development Services Director Bill Brecks.

NOTICE: Notice of the meeting was given in advance, thereof by publication in the Lexington Clipper-Herald, the designated method for giving notice, as shown by the Affidavit of Publication attached to these Minutes. Notice of this meeting was simultaneously given to the Mayor and all members of the Council, and a copy of their Acknowledgment of Receipt of Notice and the Agenda is attached to these Minutes. Availability of the Agenda was communicated in advance notice and in the notice to the Mayor and Council of this Meeting. The proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. All items presented and discussed on the Agenda were available for public inspection.

CALL TO ORDER: The meeting was called to order by Mayor Fagot. Fagot informed the public that the Open Meetings Act is posted in the Meeting Room at the Lexington City Hall, located at 406 E. 7th Street, Lexington, Nebraska.

PLUM CREEK PARK: Council and Staff discussed plans involving proposed playground improvements in Plum Creek Park.

FIELDHOUSE: Council and Staff discussed the status of fundraising activities for the Lexington Fieldhouse project. The meeting was adjourned at 8:50 a.m. to travel to the WWTP to tour recent facility improvements.

WWTP: The meeting was reconvened at 9:00 a.m. at the WWTP facility, 1110 E Industry Drive. Doug Glaze, WWTP Superintendent, gave a tour of the recent improvements made to the plant. Following discussion, the meeting was adjourned at 10:00 a.m. to travel to the Opportunity Center.

COMMERCIAL DEVELOPMENT: The meeting was reconvened at 10:10 am at the Opportunity Center, 1503 Plum Creek Parkway to discuss and tour proposed commercial development on city owned property at 1601 Plum Creek Parkway, south of the Opportunity Center. Following discussion, the meeting was adjourned at 10:50 a.m. to travel to Plum Creek Park.

PARK IMPROVEMENTS: The meeting was reconvened 11:00 a.m. to tour planned park improvements at Plum Creek Park, southwest of the intersection of 13th and Adams Streets. Following discussion, the meeting was adjourned at 12:00 p.m. with no further business.
