FINANCIAL REPORT: Moved by Roberts, seconded by Vivas, to accept the financial report for September 2015 as presented. Roll call. Voting "aye" were Miller, Vivas, Roberts, Fagot. Motion carried.

CONDITIONAL USE PERMIT: Mayor Fagot open a public hearing to consider a conditional use permit application for property located at 203 E Pacific. Brecks indicated that the owner and tenant of the property would like to expand the current vehicle sales business to include low volume mechanical service work which is only allowable by conditional use in a C-2 zoned area. He noted the Planning Commission recommended approval of the conditional use with a restriction of only three vehicles to be stored outdoors on the property for service activities. Pepplitsch reviewed a draft conditional use agreement, which included the vehicle storage restriction. Mr. Nava, property tenant, supported the application. With no further comment, the public hearing was closed. Following discussion, moved by Vivas, seconded by Miller, to approve the conditional use permit application as the use is deemed appropriate per conditional use standards, and authorize execution of the

conditional use agreement as presented. Roll call. Voting "aye" were Roberts, Miller, Vivas, Fagot. Motion carried.

PUBLIC HEARING: Mayor Fagot opened a public hearing to consider an amended redevelopment plan for Redevelopment Area #1. Pepplitsch reviewed the amended plan, including the establishment and paving of Commerce Road approximately 425' west of the current Commerce Road/Hwy 283 intersection and associated storm water drainage. He noted that excess TIF proceeds were realized from the original project and the amended plan would utilize those funds to construct the public improvements. He also noted the CDA and the Planning Commission have both reviewed the amended plan and recommend approval. Following discussion, the public hearing was closed. Resolution No. 2015-17 was presented. Moved by Miller, seconded by Vivas, to approve Resolution No. 2015-17. Voting "aye" were Roberts, Vivas, Miller, Fagot. Motion carried.

RESOLUTION NO. 2015-17

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA APPROVING AN AMENDED REDEVELOPMENT PLAN AND RELATED MATTERS.

WHEREAS, the city of Lexington, Nebraska, a municipal corporation (the "City"), has determined it to be desirable to undertake and carry out urban redevelopment projects in certain areas of the City that are determined to be blighted and substandard and in need of redevelopment; and

WHEREAS, the Community Development Law, Chapter 18, Article 21, Reissue Revised Statutes of Nebraska, as amended (the "Act"), prescribes the requirements and procedures for the planning and implementation of redevelopment projects; and

WHEREAS, the City has previously declared the area legally described in Exhibit A attached hereto (the "Redevelopment Project Area") to be blighted and substandard and in need of redevelopment pursuant to the Act; and

WHEREAS, the Community Development Agency of Lexington, Nebraska (the "Community Development Agency") has prepared an Amended Redevelopment Plan (the "Redevelopment Plan"), in the form attached hereto as Exhibit B, for the redevelopment of the Redevelopment Project Area; and

WHEREAS, the Community Development Agency and the Planning Commission of the City (the "Planning Commission") have both reviewed the Redevelopment Plan and recommended its approval by the Mayor and City Council of the City; and

WHEREAS, the City published and mailed notices of a public hearing regarding the consideration of the approval of the Redevelopment Plan pursuant to Section 18-2115 of the Act, and has on the date of this Resolution held a public hearing on the proposal to approve the Redevelopment Plan; and

WHEREAS, the City has reviewed the Redevelopment Plan and determined that the proposed land uses and building requirements described therein are designed with the general purpose of accomplishing a coordinated, adjusted, and harmonious development of the City and its environs which will, in accordance with present and future needs, promote health, safety, morals, order, convenience, prosperity and the general welfare, as well as efficiency in economy in the process of development; including, among other things, adequate provision for traffic, vehicular parking, the promotion of safety from fire, panic, and other dangers, adequate provisions for light and air, the promotion of the healthful and convenient distribution of population, the provision of adequate transportation, water, sewerage, and other public utilities, schools, parks, recreational and community facilities, and other public requirements, the promotion of sound design and arrangement, the wise and efficient expenditure of public funds, and the prevention of the recurrence of unsanitary or unsafe dwelling accommodations, or conditions of blight.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. The Redevelopment Plan is hereby determined to be feasible and in conformity with the general plan for the development of the City as a whole, and the Redevelopment Plan is in conformity with the legislative declarations and determinations set forth in the Act; and it is hereby found and determined, based on the analysis conducted by the Community Development Agency, that (a) the redevelopment project described in the Redevelopment Plan would not be economically feasible without the Project Area without the use of taxincrement financing, and (b) the costs and benefits of the redevelopment project, including costs and benefits to other affected political subdivisions, the economy of the City, and the demand for public and private services have been analyzed by the City and have been found to be in the long-term best interest of the community impacted by the redevelopment project.

Section 2. The Redevelopment Plan is hereby approved in substantially the form attached hereto, with such immaterial changes, additions, or deletions thereto as may be determined to be necessary by the Agency in its sole and absolute discretion.

Section 3. In accordance with Section 18-2147 of the Act, the City hereby provides that any ad valorem tax on real property in the Project Area for the benefit of any public body be divided as follows for a period of 15 years after the effective date of this provision as provided in Section 18-2147 of the Act, which effective date is January 1, 2001. Said tax shall be divided as follows:

- (a) That proportion of the ad valorem tax which is produced by levy at the rate fixed each year by or for each public body upon the Redevelopment Project Valuation (as defined in the Act) shall be paid into the funds of each such public body in the same proportion as all other taxes collected by or for the bodies; and
- (b) That proportion of the ad valorem tax on real property in the Project Area in excess of such amount (the Redevelopment Project Valuation), if any, shall be allocated to, is pledged to, and, when collected, paid into a special fund of the Agency to pay the principal of, the interest on, and any premiums due in connection with the bonds, loans, notes or advances of money to, or indebtedness incurred by, whether funded, refunded, assumed, or otherwise, such Agency for financing or refinancing, in whole or in part, the Project. When such bonds, loans, notes, advances of money, or indebtedness, including interest and premium due have been paid, the Agency shall so notify the County Assessor and County Treasurer and all ad valorem taxes upon real property in the Project Area shall be paid into the funds of the respective public bodies.

Section 4. The Mayor and Clerk are hereby authorized and directed to execute such documents and take such further actions as are necessary to carry out the purposes and intent of this Resolution and the Redevelopment Plan.

PASSED AND APPROVED this 27th day of October, 2015.

CONTRACT: Pepplitsch reviewed a proposed wholesale power contract with Nebraska Public Power District, to become effective January 1, 2016. Following discussion, moved by Miller, seconded by Roberts, to approve the proposed 2016 Wholesale Power Contract (Option A) and authorize the City Manager to execute the contract. Roll call. Voting "aye" were Vivas, Roberts, Miller, Fagot. Motion carried.

ENGINEERING SERVICES: Pepplitsch reviewed the process taken to procure engineering services for the pending CDBC Project No. 14-CIS-002. He indicated staff recommends awarding Miller & Associates a contract for the services. Following discussion, moved by Roberts, seconded by Miller, to award engineering services for CDBG 14-CIS-002, contingent upon grant award release. Roll call. Voting "aye" were Vivas, Miller, Roberts, Fagot. Motion carried.

APPOINTMENT: Fagot proposed that Cheryl Burnside be appointed to the Library Board to fill a current vacancy. Moved by Miller, seconded by Roberts, to approve the appointment as presented. Roll call. Voting "aye" were Vivas, Roberts, Miller, Fagot. Motion carried.

ROUNDTABLE DISCUSSION: Pepplitsch gave an update on current projects.

ADJOURNMENT: There being no further business to come before the Council, Fagot declared the meeting adjourned.
