RESOLUTION: Resolution No. 2018-05 was presented. Following discussion, moved by Salem, seconded by Smith, to approve Resolution No. 2018-05. Roll call. Voting "aye" were Vivas, Smith, Salem, Fagot. Motion carried.

NORTHWEST TRAIL: Pepplitsch presented plans and specifications for the Hike/Bile Trail Northwest Segment project and requested authorization to solicit bids. After reviewing the project, moved by Salem, seconded by Vivas, to approve plans and specs for the Hike/Bike Trail Northwest Segment and to authorize the City Manager to solicit bids. Roll call. Voting "aye" were Smith, Vivas, Salem, Fagot. Motion carried.

LOAN AGREEMENT 2018-01: Pepplitsch presented proposed Loan Agreement No. 2018-01 under the Lexington Revolving Loan Fund. He reviewed the loan conditions and agreement between RRTABS Investments LLC and the City for acquisition and rehabilitation of the former Wendy's Restaurant building. Following the review and recommendation, moved by Smith, seconded by Salem, to approve Loan Agreement 2018-01 as presented. Roll call. Voting "aye" were Vivas, Salem, Smith, Fagot. Motion carried.

LOAN AGREEMENT 2018-02: Pepplitsch presented proposed Loan Agreement No. 2018-02 under the Lexington Revolving Loan Fund. He reviewed the loan conditions and agreement between McFarland Family Farms, LLC, and the City for an expansion project to increase production capacity for their business. Following the review and recommendation, moved by Vivas, seconded by Salem, to approve Loan Agreement 2018-02 as presented. Roll call. Voting "aye" were Salem, Smith, Vivas, Fagot. Motion carried.

ROUNDTABLE: Pepplitsch reminded Council and Staff of the work session scheduled for Saturday, April 14, 2018, at 8:00 a.m. He also indicated that a census tract that includes a large portion of Lexington has been designated as an Opportunity Zone by the federal government, which is a new community development program established in the Tax Cuts and Jobs Act of 2017.

ADJOURNMENT: There being no further business to come before the Council, Fagot declared the meeting adjourned.
