A Regular Meeting of the Lexington City Council was held Tuesday, Tuesday, August 27, 2019, at the Lexington City Hall, 406 E. 7<sup>th</sup> Street, Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, Steve Smith and Jeremy Roberts. Dora Vivas was absent. City Officials present were City Manager Joe Pepplitsch, Assistant City Manager Dennis Burnside, City Attorney Brian Copley, Community Development Director Bill Brecks, Finance Director Barb Hodges, and City Clerk Pamela Baruth. The press was represented by Clipper-Herald and Tri-City Trib.

**PUBLIC HEARING:** Mayor Fagot opened a public hearing to consider a final plat of the Northeast First Addition. Pepplitsch reviewed the plat of City owned property. Voting "aye" were Smith, Roberts, Salem, Fagot. Motion carried.

the City for all purposes whatsoever and the inhabitants of the Addition shall be entitled to all the rights and privileges and be subject to all the laws, ordinances, rules and regulations of the City.
