City Officials present were City Manager Joe Pepplitsch, Assistant City Manager Dennis Burnside, City Attorney Brian Copley, Finance Director Barb Hodges and City Clerk Pamela Baruth. ACCOUNTS RECEIVABLE: Pepplitsch reviewed delinquent account receivable balances that have been deemed uncollectible. Following discussion, moved by Smith, seconded by Roberts, to authorize Staff to remove uncollectible account receivable balances as presented. Roll call. Voting "aye" were Salem, Roberts, Smith, Fagot. Motion carried.

LOCAL DISASTER DECLARATION: Pepplitsch requested Council ratify a Local Disaster Declaration due to flooding beginning July 8, 2019. He explained this is the initial step in the process in becoming eligible for potential disaster relief funds for the city and its citizens. Moved by Smith, seconded by Salem, to ratify the Local disaster Declaration as presented. Roll call. Voting "aye" were Roberts, Salem, Smith, Fagot. Motion carried.

ROUNDTABLE: Pepplitsch reminded Council and Staff of the work session scheduled for Saturday, July 13, 2019, at 8:00 a.m. Roberts also expressed appreciation for the public works, police, and city personnel for their work during the recent flooding.

ADJOURNMENT: There being no further business to come before the Council, Fagot declared the meeting adjourned.
