A Regular Meeting of the Lexington City Council was held Tuesday, April 28, 2020, by conference call at Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, Dora Vivas, and Steve Smith. Jeremy Roberts was absent. City Officials present were City Manager Joe Pepplitsch, Assistant City Manager Dennis Burnside, City Attorney Brian Copley, Finance Director Barb Hodges, and City Clerk Pamela Baruth. The press was represented by Lexington Clipper-Herald.

18TH **STREET PROJECT:** Pepplitsch presented a bid tabulation and engineer recommendation for the 18th Street Paving Improvements project and requested to award the bid to TL Sund Constructors for \$95,638.00. Following discussion, moved by Salem, seconded by Vivas, to accept the bids, award a project contract to TL Sund Constructors for the 18th Street Paving Improvement project, and authorize the execution of necessary documents. Roll call. Voting "aye" were Smith, Vivas, Salem, Fagot. Motion carried.

ROUNDTABLE DISCUSSION: Pepplitsch gave an update on various projects and the COVID-19 crisis.

ADJOURNMENT: There being no further business to come before the Council, Fagot declared the meeting adjourned.
