A Regular Meeting of the Lexington City Council was held Tuesday, June 23, 2020, at the Lexington City Hall, 406 E. 7th Street, Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, Dora Vivas, Steve Smith and Jeremy Roberts. City Officials present were City Manager Joe Pepplitsch, Assistant City Manager Dennis Burnside, City Attorney Brian Copley, Finance Director Barb Hodges, Community Development Director Bill Brecks and City Clerk Pamela Baruth. FINANCIAL REPORT: Moved by Smith, seconded by Vivas, to accept the financial report for May 2020 as presented. Roll call. Voting "aye" were Salem, Roberts, Vivas, Smith, Fagot. Motion carried.

PUBLIC HEARING: Mayor Fagot opened a public hearing to consider a Conditional Use Permit application by Valente and Miguel Pinedo for a family dwelling at 113 West 5th Street. Brecks reviewed the plans for a family dwelling and hair salon, stating there is adequate parking for both areas. Miguel Pinedo explained that a family member acting as a manager will likely occupy the dwelling. Brecks noted the Planning Commission recommended approval of the application. There were no public comments, and the public hearing was closed.

Moved by Salem, seconded by Vivas, to approve the CUP application as presented. Roll call. Voting "aye" were Smith, Roberts, Vivas, Salem, Fagot. Motion carried.

PUBLIC HEARING: Mayor Fagot opened a public hearing to consider a Conditional Use Permit application by Viaero Wireless Inc to construct an 80-foot monopole communications tower in a C-3 Highway Commercial Zone at the southwest corner of Frontier Road and Plum Creek Parkway. Brecks reviewed the application and draft CUP agreement, stating the Planning Commission had recommended approval of the application. Chris Riha, Viaero Wireless, noted final design of the retail store and office suites are contingent of final purchase of the property. He stated the project would be completed in 2021. There were no public comments, and the public hearing was closed. Moved by Roberts, seconded by Salem, to approve the CUP application as presented. Roll call. Voting "aye" were Vivas, Salem, Roberts, Fagot. Smith abstained. Motion carries.

ORDINANCE: Ordinance No. 2428 entitled "AN ORDINANCE APPOINTING A CITY MANAGER; TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was presented on first reading. Moved by Salem, seconded by Roberts, to suspend the rules regarding the reading of an ordinance on three separate occasions. Roll call. Voting "aye" were Vivas, Smith, Roberts, Salem, Fagot. Motion carried.

Ordinance No. 2428 was read on final reading. Moved by Salem, seconded by Smith, to approve Ordinance No. 2428 on final reading. Roll call. Voting "aye" were Vivas, Roberts, Smith, Salem, Fagot. Motion carried.

ROUNDTABLE DISCUSSION: Pepplitsch gave an update on current projects.

ADJOURNMENT: There being no further business to come before the Council, Fagot declared the meeting adjourned.
