A Regular Meeting of the Lexington City Council was held Tuesday, November 9, 2021, at Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, Dora Vivas Steve Smith, and Jeremy Roberts. PUBLIC HEARING: Mayor Fagot opened a public hearing to consider an application to rezone the Northwest Ninth Addition from A-1 Agricultural to R-1 Single-Family Residential. Pepplitsch explained the area is platted for residential units and the zoning change would conform to the adjoining areas. He noted the Planning Commission has recommended approval of the zoning change following their public hearing. There being no public comments, the public hearing was closed. Ordinance No. 2442 entitled "AN ORDINANCE TO REZONE THE NORTHWEST NINTH ADDITION, AN ADDITION TO THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA FROM A-1 AGRICULTURAL TO R-1 SINGLE-FAMILY RESIDENTIAL; TO REPEAL ALL ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM" was presented on first reading. Following discussion, moved by Salem, seconded by Smith, to suspend the rules regarding the reading of an ordinance on three separate occasions. Roll call. Voting "aye" were Vivas, Roberts, Smith, Salem, Fagot. Motion carried.

Ordinance No. 2442 was presented of Final reading. Moved by Salem, seconded by Roberts, to approve Ordinance No. 2442 on Final reading. Roll call. Voting "aye" were Vivas, Smith, Roberts, Salem, Fagot. Motion carried.

**PROJECT:** Pepplitsch reviewed bids received for the 18<sup>th</sup> Street Phase 2 and Kirkpatrick Memorial Park Paving Improvements projects. Moved by Roberts, seconded by Vivas, to accept the bids received and to award the contract to Paulsen Inc. as low bidder at \$532,273. Roll call. Voting "aye" were Smith, Salem, Vivas, Roberts, Fagot. Motion carried.

**PAY REQUEST:** Pepplitsch reviewed Pay Request #2 from Walters-Morgan Construction for the 2021 Wastewater Facility Improvements project in the amount of \$185,177.39. Following discussion, moved by Smith, seconded by Roberts, to approve Pay Request #2 for the 2021 Wastewater Facility Improvements project as presented. Roll call. Voting "aye" were Vivas, Salem, Roberts, Smith, Fagot. Motion carried.

**WORK SESSION:** Moved by Salem, seconded by Vivas, to schedule a work session for Saturday, November 20, 2021, at 8:00 a.m. Roll call. Voting "aye" were Smith, Roberts, Vivas, Salem, Fagot. Motion carried.

**ADJOURNMENT:** There being no further business to come before the Council, Fagot declared the meeting adjourned.
