Roll call. Voting "aye" were Vivas, Roberts, Salem, Smith, Fagot. Motion carried.

RESOLUTION NO. 2021-21

A RESOLUTION SETTING THE PROPERTY TAX REQUEST FOR FISCAL YEAR 2021-2022 AT A DIFFERENT AMOUNT THAN THE PRIOR YEAR REQUEST.

WHEREAS, Nebraska Revised Statute 77-1601.02 provides that the Governing Body of the city of Lexington passes by a majority vote a resolution setting the tax request; and

WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request;

NOW, THEREFORE, the Governing Body of the city of Lexington resolves that:

- 1. The 2021-2022 property tax request be set at \$1,486,289.00.
- 2. The total assessed value of property differs from last year's total assessed value by 1.65%.
- 3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be \$.355642 per \$100 of assessed value.

- 4. The city of Lexington proposes to adopt a property tax request that will cause its tax rate to be .361502 per \$100 of assessed value.
- 5. Based on the proposed tax request and changes in other revenue, the total operating budget of the city of Lexington will be more than last year's by 30%.
- 6. A copy of this resolution shall be certified and forwarded to the Dawson County Clerk on or before October 13, 2021.
