CITY COUNCIL CITY OF LEXINGTON, NEBRASKA June 27, 2023

A Regular Meeting of the Lexington City Council was held Tuesday, June 27, 2023, at Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, Steve Smith, and Jeremy Roberts. Dora Vivas was excused. City Officials present were City Manager Joe Pepplitsch, Assistant City Manager Dennis Burnside, City Attorney Brian Copley, Finance Director Barb Hodges and City Clerk Pamela Baruth. The press was represented by the Clipper-Herald.

RESOLUTION NO. 2023-12

WHEREAS, the Lexington Airport Authority has requested an allocation of a portion of the City of Lexington property tax levy for budget purposes.

BE IT RESOLVED, by the Mayor and Council of the City of Lexington, Nebraska, that \$165,882 of the City of Lexington Property Tax Levy Authority is hereby allocated to the Lexington Airport Authority for the fiscal year 2023-2024.

RESOLUTION NO. 2023 – 13

A RESOLUTION OF THE CITY OF LEXINGTON, NEBRASKA, AUTHORIZING AND DIRECTING THE TRANSFER OF REAL ESTATE TO THE COMMUNITY DEVELOPMENT AGENCY OF LEXINGTON, NEBRASKA.

WHEREAS, the City of Lexington owns certain real estate for the purpose of residential housing development; and

WHEREAS, the Community Development Agency of Lexington, Nebraska is preparing a housing development project involving the same real estate, and it is in the best interest of the City to aid and cooperate in the planning, undertaking and carrying out of said development project by transferring title to said real estate to the Community Development Agency.

BE IT THEREFORE RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, as follows:

That the City Manager is hereby directed and authorized on behalf of the City of Lexington, to execute a Deed, transferring to the Community Development Agency of Lexington, Nebraska, the following described real estate, to-wit:

Lots 2, 3, 4, 5, and 6, Wycoff 2nd Addition, a replat of Lot 3 Wycoff Addition to the City of Lexington, Dawson County, Nebraska.

Passed and approved June 27, 2023.

RESOLUTION NO. 2023-14

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA ASSIGNING A PURCHASE CONTRACT TO THE COMMUNITY DEVELOPMENT AGENCY OF LEXINGTON, NEBRASKA

WHEREAS, the City of Lexington, Nebraska, a municipal corporation and city of the first class (the "City"), has determined it to be in the best interests of the City to convey the real estate set forth on **Attachment 1** to the Community Development Agency of Lexington, Nebraska for the purposes of redevelopment, specifically, housing development; and

WHEREAS, the City has previously entered into a purchase contract for the sale of said real estate, the form of which is attached hereto as **Attachment 2** attached hereto (the "Purchase Agreement"); and

WHEREAS, it is necessary to assign the Purchase Agreement to the Community Development Agency of Lexington, Nebraska;

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. The Purchase Agreement attached hereto as Attachment 2, related to the real estate legally described on Attachment 1, is hereby assigned to the Community Development Agency of Lexington, Nebraska

PAY REQUEST: Pepplitsch reviewed Pay Request #10 from Lacy Construction for the Veteran's Pavilion at Kirkpatrick Memorial Park project in the amount of \$71,540.01. Following a project update, moved by Roberts, seconded by Salem, Fagot. Roll call. Voting "aye" were Smith, Salem, Roberts, Fagot. Motion carried.

ROUNDTABLE: Pepplitsch gave an update on local projects.

ADJOURNMENT: There being no further business to come before the Council, Fagot declared the meeting adjourned.
