CITY COUNCIL CITY OF LEXINGTON, NEBRASKA November 28, 2023

A Regular Meeting of the Lexington City Council was held Tuesday, November 28, 2023, at Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, Dora Vivas, Steve Smith, and Jeremy Roberts. City Officials present were City Manager Joe Pepplitsch, Assistant City Manager Dennis Burnside, City Attorney Brian Copley, Finance Director Derek Haines, Community Development Director Bill Brecks and City Clerk Pamela Baruth. The press was represented by The Clipper-Herald.

Ellen Priel questioned the ability for seniors to drive though Kirkpatrick Memorial Park for the holiday light display. She was directed to contact Pepplitsch to discuss. Nola Reed commented on cemetery operations and recycling trailers being removed from school locations.

PUBLIC HEARING: Mayor Fagot opened a public hearing to review a 1&6 Year Street Improvement Plan. Pepplitsch reviewed the plan and projects. There were no public comments, and the public hearing was closed. Resolution No. 2023-23 was presented. Following discussion, moved

by Salem, seconded by Smith, to approve Resolution No. 2023-23 as presented. Roll call. Voting "aye" were Vivas, Roberts, Smith, Salem, Fagot. Motion carried.

RESOLUTION: Pepplitsch presented Resolution No. 2023-24 setting utility fees. Following discussion, moved by Smith, seconded by Roberts, to approve Resolution No. 2023-24 as presented. Roll call. Voting "aye" were Vivas, Salem, Roberts, Smith, Fagot. Motion carried.

RESOLUTION NO. 2023 - 24

WHEREAS Lexington City Code Sections 28-232 and 28-439 authorizes the City Council to establish by Resolution a schedule of rates and charges for water service and sanitary sewer service.

BE IT THEREFORE RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, that the following rates and charges are established and shall take effect January 1, 2024, to be reflected on billings following such date. That all other electric rates, water rates, and sanitary sewer rates and charges previously established shall remain unchanged.

Section 1. Water Rates

Residential Metered: The first 5,000 gallons \$20.75 monthly minimum

> 5,000 gallons \$1.05 per 1,000 gallons

Residential Flat Rate: \$27.75 per dwelling unit per month

Commercial Metered: The first 5,000 gallons \$20.75 monthly minimum

> 5,000 gallons \$1.05 per 1,000 gallons

Multi-unit Service Fee: \$13.75 per dwelling/commercial unit, where more than one

dwelling/commercial unit is served by a single metered service.

Industrial Metered: Base Charge per Month -- \$2,530

\$0.380 per 1,000 gallons metered use

Automated Meter Reading Fee: \$1.00 per month per metered or unmetered service.

Section 2. Sanitary Sewer Rates

Flat Rate Residential: \$27.35 per month.

Flat Rate Commercial: \$27.35 per month

Commercial Metered: \$2.74 per 1,000 gallons

\$27.35 minimum

RESOLUTION NO. 2023-25 A RESOLUTION AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH THE NEBRASKA DEPARTMENT OF TRANSPORTATION FOR:

Installation and Operation of Automated License Plate Reader on State Highway

Whereas: The City and State wish to enter into an Agreement for the Installation and Operation of Automated License Plate Readers (ALPRs) on State Highway within City; and

Whereas: This Agreement is intended to set out the various responsibilities and duties of the City and State regarding the installation, operation and maintenance of the ALPRs; and

Whereas: The City understands that it must strictly follow all Federal, State and local laws, rules, regulations, policies and guidelines applicable to the installation, operation and maintenance of ALPRs.
