A Regular Meeting of the Lexington City Council was held Tuesday, October 10, 2023, at Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, Dora Vivas, Steve Smith, and Jeremy Roberts. City Officials present were City Manager Joe Pepplitsch, Assistant City Manager Dennis Burnside, City Attorney Brian Copley, and Finance Director Derek Haines. The press was represented by The Clipper-Herald.

EXECUTIVE SESSION: Moved by Roberts, seconded by Vivas, to enter Executive Session at 5:37 p.m. to discuss negotiations for purchase of real estate. Roll call. Voting "aye" were Smith, Salem, Vivas, Roberts, Fagot. Motion carried.

Moved by Roberts, seconded by Vivas, to enter Open Session at 6:20 p.m. Roll call. Voting "aye" were Smith, Salem, Vivas, Roberts, Fagot. Motion carried.

ADJOURNMENT: There being no further business to come before the Council, Fagot declared the meeting adjourned.
