## CITY COUNCIL CITY OF LEXINGTON, NEBRASKA October 24, 2023

A Regular Meeting of the Lexington City Council was held Tuesday, October 24, 2023, at Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, Dora Vivas, and Jeremy Roberts. Steve Smith was absent. City Officials present were City Manager Joe Pepplitsch, Assistant City Manager Dennis Burnside, City Attorney Brian Copley, Finance Director Derek Haines and City Clerk Pamela Baruth. The press was represented by The Clipper-Herald.

**FINANCIAL REPORT:** Moved by Roberts, seconded by Vivas, to accept the financial report for September 2023 as presented. Roll call. Voting "aye" were Salem, Vivas, Roberts, Fagot. Motion carried.

PUBLIC HEARING: Mayor Fagot opened a public hearing to consider an application for a Planned Unit Development Overlay District for property located at 1231 Liberty Drive for senior housing project. Pepplitsch reviewed the plans for the senior housing project to include row housing, community center, recreation amenities, and infrastructure. He noted the PUD Overlay would allow for amended setback requirements to accommodate the layout and type of housing units. There were no public comments, and the public hearing was closed. Ordinance No. 2458 entitled "AN ORDINANCE TO APPROVE A PLANNED UNIT DEVELOPMENT OVERLAY DISTRICT FOR LOTS 1-7, WYCOFF 2<sup>ND</sup> ADDITION; TO REPEAL ALL ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN ELECTRONIC FORM" was presented on first reading. Moved by Salem, seconded by Roberts, to suspend the rules regarding the reading of an ordinance on three separate occasions. Roll call. Voting aye were Vivas, Roberts, Salem, Fagot. Motion carried.

Ordinance No. 2458 was presented on final reading. Moved by Salem, seconded by Roberts, to approve Ordinance No. 2458 on final reading. Roll call. Voting "aye" were Vivas, Roberts, Salem, Fagot. Motion carried.

**ROUNDTABLE DISCUSSION:** Pepplitsch gave updates on several current projects.

**ADJOURNMENT:** There being no further business to come before the Council, Fagot declared the meeting adjourned.
