A Regular Meeting of the Lexington City Council was held Tuesday, September 12, 2023, at Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, Dora Vivas, Steve Smith, and Jeremy Roberts. Sec. IV. Be it further resolved that the power and authority granted in this Resolution shall continue in full force and effect until notice in writing is given to said banks of the cancellation or modification hereof.
