A Regular Meeting of the Lexington City Council was held Tuesday, April 9, 2024, at Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, Dora Vivas, Steve Smith, and Jeremy Roberts.
