# CITY COUNCIL CITY OF LEXINGTON, NEBRASKA December 23, 2024

A Regular Meeting of the Lexington City Council was held Monday, December 23, 2024, at Lexington, Nebraska at 12:00 p.m. Members of the Council present were John Fagot, John Salem, Jared Jacob, and Jeremy Roberts. Dora Vivas was absent. City Officials present were City Manager Joe Pepplitsch, Assistant City Manager Dennis Burnside, City Attorney Brian Copley, Finance Director Derek Haines, Community Development Director Bill Brecks and City Clerk Pamela Baruth. The press was represented by Clipper-Herald.

Availability of the Agenda was communicated in advance notice and in the notice to the Mayor and Council of this Meeting. The proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. All items presented and discussed on the agenda were available for public inspection.

**CALL TO ORDER:** The meeting was called to order by Mayor Fagot. Fagot informed the public that the Open Meetings Act is posted in the Meeting Room at the Lexington City Hall, 406 E. 7th Street, Lexington, Nebraska.

He stated the agreement is for \$200,000 loan for 10 years at 2% annual interest to be used as capital for the development project. Moved by Salem, seconded by Roberts, to approve the loan agreement as presented and authorize execution of necessary documents. Roll call. Voting "aye" were Jacob, Roberts, Salem, Fagot. Motion carried.
