## CITY COUNCIL CITY OF LEXINGTON, NEBRASKA February 27, 2024

A Regular Meeting of the Lexington City Council was held Tuesday, February 27, 2024, at Lexington, Nebraska at 5:30 p.m. Members of the Council present were John Fagot, John Salem, Dora Vivas, Steve Smith and Jeremy Roberts. **FINANCIAL REPORT:** Moved by Smith, seconded by Salem, to accept the financial report for January 2024 as presented. Roll call. Voting "aye" were Vivas, Roberts, Salem, Smith, Fagot. Motion carried.

ORDINANCE: Ordinance No. 2461 entitled "AN ORDINANCE TO REZONE A CERTAIN TRACT OF REAL ESTATE TO R-1; TO REPEAL ALL ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN ELECTRONIC FORM" was presented. Pepplitsch noted the ordinance had been carried over from the previous meeting. Moved by Vivas, seconded by Smith, to suspend rules regarding the reading of an ordinance on three separate occasions. Roll call. Voting "aye" were Salem, Roberts, Smith, Vivas, Fagot. Motion carried.

Ordinance No. 2461 was presented on final reading. Moved by Vivas, seconded by Roberts, to approve Ordinance No. 2461. Roll call. Voting "aye" were Smith, Salem, Roberts, Vivas, Fagot. Motion carried.

PUBLIC HEARING: Mayor Fagot opened a public hearing to consider an amendment to Section 5.13.06 of the Lexington Zoning Code. Pepplitsch noted that the amendment is being proposed by staff to accommodate current development trends in the hotel/motel business for taller structures, raising the maximum height restrictions in the C-3 zone, and the Planning Commission has recommended Council approval. There being no public comments received or heard, the public hearing was closed. Ordinance No. 2462 entitled "AN ORDINANCE TO AMEND SECTION 5.13.06 OF THE ZONING ORDINANCE OF THE CITY OF LEXINGTON, NEBRASKA; TO REPEAL ORIGINAL SECTION 5.13.06, AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN ELECTRONIC FORM" was presented. Moved by Salem, seconded by Roberts, to suspend rules regarding the reading of an ordinance on three separate occasions. Roll call. Voting "aye" were Vivas, Smith, Roberts, Salem, Fagot. Motion carried.

Ordinance No. 2462 was presented on final reading. Moved by Salem, seconded by Smith, to approve Ordinance No. 2462. Roll call. Voting "aye" were Vivas, Roberts, Smith, Salem, Fagot. Motion carried.

**PUBLIC HEARING:** Mayor Fagot opened a public hearing to consider a conditional use application by Alejandro Pinedo for a restaurant/bar located at 405 East Pacific. Brecks stated the use of the property as a bar requires a conditional use permit, and his office is working with the applicant to ensure parking and other requirements are met. He noted the Planning Commission has reviewed the application and recommended approval, and a draft agreement was available for review. There were no public comments, and the public hearing was closed. Following discussion, moved by Salem, seconded by Vivas, to approve a Conditional Use Permit for 405 East Pacific. Roll call. Voting "aye" were Smith, Roberts, Vivas, Salem, Fagot. Motion carried.

**RESOLUTION:** Resolution No. 2024-05 was presented. Pepplitsch reviewed the requested rate increase. Following discussion, moved by Roberts, seconded by Vivas, to approve Resolution No. 2024-05. Roll call. Voting "aye" were Smith, Salem, Vivas, Roberts, Fagot. Motion carried.

## **RESOLUTION NO. 2024-05**

WHEREAS, Section 28-467 of the Lexington City Code authorizes the City Council to establish by resolution the charges and fees for collection of refuse and garbage, and;

WHEREAS, an increase in operating expenses justifies an increase in existing rates.

BE IT THEREFORE RESOLVED, that effective March 1, 2024, the charge to be collected for residential garbage pickup within the City of Lexington shall be \$17.50 per month, plus an administrative charge of \$1.00, for a total of \$18.50 per month.

BE IT FURTHER RESOLVED, that effective March 1, 2024, the charge for residential customers who are single and 65 years of age or older and living alone shall be \$15.50, plus administrative charge of \$1.00, for a total of \$16.50 per month.

Following an update, moved by Smith, seconded by Vivas, to approve Well #10 Water Main Project closeout documents for Van Kirk Bros. Contracting as presented. Roll call. Voting "aye" were Salem, Roberts, Smith, Vivas, Fagot. Motion carried.

**WORK SESSION:** Moved by Roberts, seconded by Vivas, to schedule a council work session for Saturday, March 9, 2024, at 8:00 a.m. Roll call. Voting "aye" were Smith, Salem, Vivas, Roberts, Fagot. Motion carried.

**ROUNDTABLE:** Pepplitsch gave an update on current projects. Brecks introduced staff members Jason Harris and Jose Ramirez.

**ADJOURNMENT:** There being no further business to come before the Council, Fagot declared the meeting adjourned.
