CALL TO ORDER: The Meeting was called to order by Chair Gail Hall who informed the public that the Open Meetings Act is posted in the Council Chambers at the Lexington City Hall, located at 406 E. 7th Street, Lexington, Nebraska.

ROUNDTABLE: Pepplitsch stated that Staff is finalizing agreements with Central Nebraska Housing Corp. for the Ponderosa Apartment Complex expansion, which is anticipated to begin construction in the near future. He noted that Staff also continues to work on compiling an inventory of land with development/redevelopment potential for CDA and City Council discussion.
