If possible, please take your branches to the Community Service Building, 801 West Vine, during the hours listed in the sidebar article (page 2). The compost pile on East Walnut should be used only for

waste such as leaves and grass clippings. If you can't haul your downed branches, arrangements may be possible - call the Service Building at 324-5995. You can also take other debris, furniture, and appliances - a small fee may be charged.

In a related article in this issue (page 2) we have reprinted information about caring for storm-damaged trees.

Everyone is encouraged to reach out to neighbors less capable and help one another during the aftermath of our severe winter.

Lex Named Tree City USA for 10th Time

Lexington has been named a Tree City USA community by the National Arbor Day Foundation to honor its commitment to community forestry. It is the tenth year Lexington has received this national recognition.

Lexington has met the four standards to become a Tree City USA community: a Tree Board, a tree care ordinance, a comprehensive community forestry program, and an Arbor Day Observance. Lexington's Tree Board members are: Glenn Hawks, Dave Stenberg, Marty Smith, Tim Boyle and Gordon Sellin.

"Trees are a vital component of the infrastructure in our cities and towns, and provide environmental and economical benefits," said Lexington Mayor John Fagot.

Arbor Day in Lexington


Mayor John Fagot signed a proclamation this month declaring April 27 Arbor Day in Lexington. Cities across the nation celebrate this Nebraska-grown event annually to give attention to the importance of trees in our communities.

The Lexington Tree Board will honor the day with a tree planting ceremony at the Lexington Public Library at 10:00 a.m. April 27.

Baby trees: \$1 apiece (sort of)

The National Arbor Day Foundation is helping by offering 10 "free" trees to everyone who joins the NADF during April. Membership cost is \$10 – less than the cost of one tree at most nurseries, although these trees are only 6-12 inches tall. Still, who needs 10 new trees in one's yard?

Here's a suggestion: Join the NADF under this promotion, get the 10 trees, plant what you want, and donate what you don't plant to your community forest! The Lexington Tree Board is developing sites to grow such seedlings so in a few years they can be transplanted into City parks and green spaces. Just take your surplus baby trees to the Community Service Building during the hours listed below.



Advice for Storm-Damaged Trees

As the weather warms up and trees start budding many of us will finally be able to really assess the tree damage that started with the first ice storms in December. Fortunately, according to the Nebraska Forest Service, trees can go without immediate corrective attention after a storm.

Whether or not a tree survives depends upon the species, the nature of the damage, and the corrective action taken. Storm damage can be placed into five categories: broken branches, trunk bending, splitting, complete trunk failure, and tipping or uprooting.

NFS says that generally, if at least 60% or more of the crown remains, the tree should recover nicely, although it may require continued attention and

several years. First thing to do is remove

immediate hazards such as broken and hanging branches or trees with significant cracks or leaning. Larger material and limbs high in the crown should be removed by professionals.

The next step is pruning, following correct pruning standards. Although normally this means cutting a branch as close to the trunk as possible, it may be best for some branches to be trimmed near the damage area. This lets the tree grow leaves on the stub, which it will need to produce food after being stressed from the damage. This might best be assessed by a professional. The branch may be completely pruned in a year or two after the tree has recovered and grown more leaf-producing limbs.

The City will help dispose of your tree debris. It would be helpful if you can take the debris to the City Service Building, 801 W. Vine Street. Otherwise you may leave your debris near the end of your yard (not in the street) and City workers will try to pick it up.

New Management for Electric Operations

The operation and maintenance (O&M) of Lexington's electric system will be managed by Nebraska Public Power District beginning May 1. NPPD is contracted to provide the personnel, materials, and equipment necessary to maintain the physical system. The City retains system ownership, and will continue to provide customer service, electric service connections, and billing through the Lexington Utility System office in City Hall.

The transition should seem transparent and seamless to our customers; except maybe the orange bumpers and NPPD logos on the electric utility trucks. The contracting of the O&M services will provide advantages moving into the future; including efficiencies in material purchasing, outage management support, construction services, technology utilization, and system planning. Likewise, current City electrical workers will transfer to NPPD and receive improved opportunities for work experience, education, and advancement. "Taking good care of our customers and employees was our top priority as we negotiated this contract," said City Manager Joe Peplitsch, "and this arrangement will allow our customers to depend on continued quality electrical service and operations for years to come."

Customers will continue to direct question and concern about service connections, disconnections, outages, and billing to the Lexington Utility System Office at 406 E. 7th Street, Lexington, 308-324-2343.
