CITY HALL LEXINGTON, NEBRASKA

The Mayor and Council of the City of Lexington, Dawson County, Nebraska, met in regular special session in the City Hall at 8:00 o'clock P.M., on October 14, 1941 acting Mayor Louis J. Stewart presided and City Clerk Egenberger recorded the proceedings of this meeting.

The Mayor instructed the Clerk to call the roll. The Clerk called the roll and the following Councilmen were present: Ingram, Seaman, Brittan, Lincoln.

Absent: Councilman Haworth.

Whereupon the Mayor announced that the introduction of ordinances was now in order, and the matter now coming before the Mayor and Council was the passage and approval of Ordinance No. 367 of the City of Lexington, Nebraska.

This ordinance was introduced by Councilman Lincoln and is in words and figures as follows, to wit:

ORDINANCE NO. 367

Occupation Tax, Bowling Alleys, Pool and Billiard Halls.

An Ordinance levying an occupation tax upon Bowling Alleys; Pool and Billiard Halls and to provide for the collection thereof, and to repeal all ordinances or part of ordinances in conflict herewith.

Be it Ordained by the Mayor and Council, of the City of Lexington, Nebraska.

SECTION 1. That there is hereby levied an occupation tax upon the business of conducting Bowling Alleys; Pool Halls and Billiard Halls, within the corporate limits of the City of Lexington, Nebraska, in the sum of Seventy-five Dollars (\$75.00) per annum or fraction thereof, for the first alley, and the sum of Five Dollars (\$5.00) per annum or fraction thereof for each additional Alley in any one place of business; and for Pool Halls and Billiard Halls, in the sum of One Hundred Dollars (\$100.00) for the first table, per annum or fraction thereof, and the sum of Five-Dollars for each additional table, per annum or fraction thereof, in any one place of business.

SECTION 2. Said occupation tax shall be paid to the City Treasurer, of such city, on or before the 1st day of May, or at the time of making original application, and license to operate such Bowling Alley; Pool Hall and Billiard Hall, shall not be granted by the Mayor and Council, of said City, for the operation of Bowling Alleys, Pool Halls and Billiard Halls, until said occupation tax is paid. Such occupation tax and any license granted by the Mayor and Council for the operation of Bowling Alleys; Pool Halls and Billiard Halls, shall expire on the 1st day, of May, following the date on which such license is issued.

SECTION 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.
