

ORDINANCE NO. 628

ANNUAL LEVY ORDINANCE

An Ordinance making a levy for taxation on all of the taxable property within the corporate limits of the City of Lexington, Dawson County, Nebraska, for the fiscal year 1952, commencing on the 1st day of May, 1952.

BE IT ORDAINED BY THE PRESIDENT OF THE COUNCIL AND THE COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. That there is hereby levied on all the taxable property within the corporate limits of the City of Lexington, Dawson County, Nebraska, for the fiscal year 1952, the following:

RESOLUTION No. 627

WHEREAS, the President of the Council, and the City Council of the City of Lexington, Nebraska, deem it advisable and necessary to establish a sewer lateral extending from 20th Street, south of Hoover Street, to connect with existing sewer in alley in Block Five (5), Lexington Heights Addition, all in Kelly's Addition, and in Tract "H" of Suburban Addition, to the City of Lexington, Dawson County, Nebraska, and

WHEREAS, the City Engineer has filed with the City Clerk his estimate of the total cost of said improvement, and the City Council has accepted and adopted said estimate and declares the advisability and necessity for said improvement.

THEREFORE BE IT RESOLVED BY THE PRESIDENT OF THE COUNCIL, AND THE COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

1. That Sewer Lateral District No. 50 is hereby created in the City of Lexington, Nebraska.

2. Sewer Lateral District No. 50 in said City shall include all of Lots One to Ten (1 to 10) Inclusive, in Kelly's Addition and the East Twenty and Two-tenths (20.2) feet of Tract "H", Suburban Addition, and the outer boundaries of said lots and tracts shall be the outer boundary of said District.

3. That the construction of said sewer lateral is advisable and necessary and said sewer shall be laid in Hoover Street, extending from 20th Street south on said street to connect with existing sewer in alley in Block Five (5), Lexington Heights Addition to the City of Lexington.

4. Said sewer shall be constructed according to the plans and specifications of the City Engineer, using eight (8) inch cement concrete pipe or vitrified clay pipe. The Engineer's estimate of the cost of said improvement complete being the sum of \$ 2591.14.

5. The entire cost of constructing said sewer lateral in said district, complete with manholes and other accessories shall be levied and assessed against Lots One to Ten (1 to 10) inclusive, Kelly's Addition and the East Twenty and Two-tenths (20.2) feet of Tract "H", Suburban Addition, as soon as the cost thereof


may be ascertained as provided by law.
