

ORDINANCE NO. 1106

AN ORDINANCE AMENDING SECTION NINE (9), 9-204.04, 9-302, 9-303, 9-305, 9-310 AND SCHEDULE FOUR (4) OF CHAPTER NINE (9), REASSIGNING THE NUMBERS OF THE SECTIONS 9-311 AND 9-312 TO NEW NUMBERS OF 9-320 AND 9-321, OF THE MUNICIPAL CODE OF THE CITY OF LEXINGTON, NEBRASKA, PROVIDING FOR THE INSTALLATION OF PARKING METERS ON PARKING LOTS, PROVIDING FOR FAILURE TO COMPLY WITH THE PARKING METERS SECTION OF CHAPTER NINE (9), PROVIDING FOR PERMITS FOR THE PARKING OF MOTOR VEHICLES AND REVOCATION THEREOF, PROVIDING FOR THE PAYMENT AND COLLECTION OF ANNUAL PARKING PERMIT FEES, AND REPEALING ALL ORDINANCES IN CONFLICT THEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEXINGTON:

Section 1. Section 9-204.04 of the Municipal Code of the City of Lexington, Nebraska, is hereby amended to read as follows:

"9-204.03 TRAFFIC - Parking, Parking Meters. Regulations as posted on parking meters, which are installed on the streets and in City parking lots described in Schedule IV shall be enforced as provided by Parking Meter Article, 9-301 et seq."

Section 2. Section 9-302 of the Municipal Code of the City of Lexington, Nebraska is amended to read as follows:

"9-302 PARKING METERS - PARKING METER ZONES. Parking Meter Zones include all the streets as designated by Schedule IV, and City parking lots where meters are installed. The said Schedule may be changed as provided in Section 9-217."

Section 3. Section 9-303 of the Municipal Code of the City of Lexington, Nebraska, is amended to read as follows:

"9-303 PARKING METERS - INSTALLATION. The City Manager shall provide for the installation of parking meters in the designated parking meter zone, and City parking lots where meters are installed, regulate the operation thereof, and shall maintain said meters in good workable condition. Meters shall be placed upon the curb, and in parking lots where meters are installed, next to individual parking places, and meters shall be so constructed as to display a signal showing legal parking upon deposit therein of the proper coin or coins of the United States as indicated by instructions on said meter; and for a period of time as may be designated on the meter as the maximum limit of such meter; said meter shall show the expiration of such parking period by flag or signal therein."

Section 4. Section 9-305 of the Municipal Code of the City of Lexington, Nebraska, is hereby amended to read as follows:

"9-305 PARKING METERS - Parking Space, Deposit of Coins Required. When any vehicle shall be parked next to a parking meter, the owner or operator of said vehicle shall park within the area designated by the curb or street or parking lots marking lines as indicated for diagonal parking or as parrallel parking or as other-wise marked and upon entering said parking space shall immediately deposit in said meter such coin or coins of the United States for the maximum legal parking limit, or for such lesser period as may be designated by said meter. It shall be unlawful for any person to fail, refuse or neglect to so deposit the proper coin or coins as herein provided, or to fail to park within said designated area. Said parking space may then be used by such vehicle during the legal parking limit, and said vehicle shall be considered as unlawfully parking if it remains in said space for longer than the maximum limit as designated on said meter, or when said parking meter displays a signal showing such illegal parking. It shall be unlawful for any person, firm or corporation to cause or permit any vehicle registered in his or its name, to be unlawfully parked as set out in this section. Parking in parking meter zone shall be effective, Sundays excepted, during such hours as shall be designated by the City Manager on said meters."

"9-305.01 PARKING METERS - Amount of Coins Required. Amount of Coins required shall be determined by the City Manager as directed by the City Council."

Section 5. Section 9-310-a of the Municipal Code of the City of Lexington, Nebraska, is amended to read as follows:

"9-310 PARKING METERS - Failure to Comply with Sections 9-305 and 9-306.

a. By depositing the sum of Twenty-five cents (25¢) in an envelope provided by the City for such purpose on which is noted time, date and place of said violation, and placing the same in one of the special courtesy boxes located at regular intervals on the sidewalks abutting the streets or in the parking lots on which parking meters are installed or by presenting said sum and envelope to a person in charge at the Police Station within Twenty-four (24) hours after violation."

Section 6. The number of the present Sections 9-311 and 9-312 be and they are hereby renumbered Sections 9-320 and 9-321 respectively and that in all other respects the Sections shall remain the same.

Section 7. Article III of Chapter Nine (9) of the Municipal Code of the City of Lexington, Nebraska, be and it is hereby amended by the addition of Section 9-311, to read as follows:

"9-311 PARKING METERS - Permits to park on the Streets without depositing Coins. Permits to park on Streets without depositing coins may be issued to all persons having businesses in the City of Lexington, or who services businesses in the City of Lexington, or performs services within the City of Lexington to include Physcians, Teleographic, Communications, Plumbing, T. V., Building and Repair, Refrigeration Repair and Maintenance, Pick-up and Delivery Services, and other businesses who use their automobiles regularly within their business. The permit herein authorized shall not be used for motor vehicles which are otherwise prohibited from parking in such areas. A vehicle having such an authorized permit is also allowed to park in the City Parking Lots under the limitations of Section 9-312 and without paying an additional fee. Whereever used in this Section the word "person" shall be interepreted to include "firm", "corporation" or "partnership," or the plural thereof."

a. Such permits shall include on the permit the date the permit expires, the name of the person to whom the permit is issued, the make, model and color and license number of the vehicle. The application and permit shall be issued by the Clerk of the City of Lexington.

b. Permits issued under this Section shall expire on the 30th day of April following the date of issue and shall be fastened on the inside of the lower right hand corner of the windshield of the motor vehicle. The officer issuing the permit shall fasten the said permit to the vehicle.

c. An annual fee in an amount determined by the City Manager as directed by the City Council shall be paid for such parking permit. When the permit is issued after May 1st the amount to be paid for such parking permit shall be based upon the time then remaining in said permit year.

d. The said permit shall allow the person to whom it is issued to park his vehicle in spaces opposite the parking meters at any hour of the day and it shall not be necessary for the owner of said motor vehicle to deposit coins in the parking meters.

e. It shall be unlawful for any person to wilfully destroy, deface, change or alter any permit issued under the provisions of this Ordinance while the same is in force and effect.

f. The City Manager may revoke the permit issued to any violator and in case of revocation, the owner of such permit shall have the right to make claim against the City for refund of the permit he paid in proportion to length of the time remaining until such permit expires.

g. All permits issued under the provisions of this Section shall not be transferrable from one person to another and the same shall not be transferred from one car to another; Provided, however, said permit may be transferred to another automobile by the same owner upon payment of One and no/100 dollars (\$1.00) fee to the City Clerk for making such transfer."

Section 8. Article II of Chapter Nine (9) of the Municipal Code of the City of Lexington, Nebraska, be and it is hereby amended by the addition of Section 9-312, to read as follows:

"9-312 PARKING METERS - Permit to Park in City Lots without Depositing Any Coins. Permits to park in City parking lots without depositing coins may be issued to all persons for an annual fee, in an amount determined by the City Manager as directed by the City Council, to be paid for such parking permit. Wherever used in this Section the word "person" shall be interpreted as including "firm", "corporation" or "partnership" or the plural thereof.

a. Such permit shall include on the permit the date the permit expires, the name of the person to whom the permit is issued, the make, model, color and license number of the vehicle. The application and permit shall be issued by the Clerk of the City of Lexington.

b. Permits issued under this Section shall expire on the 30th day of April following the date of issue and shall be fastened on the inside of the lower right hand corner of the windshield of the motor vehicle for which issued. The officer issuing the permit shall fasten the said permit to the vehicle. When the permit is issued after May 1st the amount to be paid for the permit shall be based upon the time remaining in the said permit year.

c. The said permit shall allow the person to whom it is issued to park his vehicle, in any available space in the City parking lot at any hour of the day for not to exceed a continuous Twenty-four (24) hour period and it shall not be necessary for the owner of said motor vehicle to deposit coins in the said parking meters.

d. It shall be unlawful for any person to wilfully destroy, deface, change or alter any permit issued under the provisions of this Ordinance while the same is in force and effect.

e. The City Manager may revoke the permit issued to any violator and in case of revocation, the owner of such permit shall have the right to make claim against the City for refund of the permit he paid in proportion to length of the time remaining until such permit expires.

f. All permits issued under the provisions of this Section shall not be transferrable from one person to another and the same shall not be transferred from one car to another; Provided, however, said permit may be transferred to another automobile by the same owner upon payment of One and no/100 dollars (\$1.00) fee to the City Clerk for making such transfer."

Section 9. Schedule Four (4) to be amended to read as follows:

"SCHEDULE IV"

(Parking Meters)

Washington Street - Pacific Avenue to Seventh Street

Sixth Street - Lincoln Street to Grant Street

Seventh Street - Lincoln Street to Grant Street

Pacific Avenue - Washington Street to Grant Street

Fifth Street - Lincoln Street to Grant Street

Fourth Street - Washington Street to Grant Street

Grant Street - 6th Street to 7th Street and on East Side of Grant Street from 4th Street to 5th Street

City Parking Lots - Wherever Meters are Installed

Section 10. That any part of the existing Code or any Ordinance in conflict hereto be and the same are hereby repealed.


Section 11. That this Ordinance shall take effect and be in force from and after its publication as by law provided.
