ORDINANCE NO. 1134

AN ORDINANCE CREATING IMPROVEMENT DISTRICT NO. 141 AND PROVIDING FOR CONCRETE PAVING AND GRADING THEREIN.

BE IT ORDAINED BY THE PRESIDENT OF THE COUNCIL AND THE COUNCIL OF THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA:

Section 1. That there is hereby created within the City an Improvement District to be known as "IMPROVEMENT DISTRICT NO. 141."


Section 2. That the said Improvement District shall consist of that portion of Tyler Street from 10th Street to 9th Street, and from 9th Street to 8th Street, and from 6th Street to 5th Street and from 5th Street to 4th Street, and from 4th Street to U. S. Highway 30, and the property abutting and adjacent thereto and benefited thereby as by law provided.

Section 3. That there shall be constructed and provided on that portion of Tyler Street from 10th Street to 9th Street, and from 9th Street to 8th Street, and from 6th Street to 5th Street and from 5th Street to 4th Street, and from 4th Street to U. S. Highway 30, paving and grading which shall be in accordance with plans, specifications and estimates to be hereafter adopted.

Section 4. That the streets provided in the above section will abut on concrete paving already laid.

Section 5. That the cost of such concrete paving and grading, except street and alley intersections, shall be assessed against the lots and tracts of land abutting upon and adjacent to the said portion of streets, specifically benefited thereby, in proportion to the benefits received, to be determined by the City Council as by law provided.

NOTICE OF CREATION OF IMPROVEMENT DISTRICT NO. 141
ORDINANCE NO. 1134

Notice is hereby given that the President of the Council and the Council of the City of Lexington, Nebraska, have by Ordinance No. 1134 created Improvement District No. 141, consisting of the following described streets: That portion of Tyler Street from 10th Street to 9th Street, and from 9th Street to 8th Street, and from 6th Street to 5th Street and from 5th Street to 4th Street, and from 4th Street to U. S. Highway 30.

Unless written objections are filed with the City Clerk within twenty days after October 19, 1967, as by law provided, the President of the Council and Council will proceed with the construction of concrete paving and grading on that portion of Tyler Street from 10th Street to 9th Street, and from 9th Street to 8th Street, and from 6th Street to 5th Street and from 5th Street to 4th Street, and from 4th Street to U. S. Highway 30. Said construction in said district shall be in accordance with Ordinance No. 1134 above referred to and the costs thereof, except street and alley intersections, shall be assessed to the abutting and adjacent property of said district as by law provided, specifically benefited thereby in proportion to benefits received.
