ORDINANCE NO. 1242

AN ORDINANCE ADDING CHAPTER 8-A "EMERGENCY SITUATIONS" TO THE CODE, DEFINING A STATE OF EMERGENCY ARISING IN THE CITY OF LEXINGTON, NEBRASKA, DELEGATING CERTAIN POWERS TO THE CITY MANAGER, AND REQUIRING CERTAIN ACTIONS BY THE CITY MANAGER TO MAINTAIN THE PEACE.

BE IT ORDAINED BY THE PRESIDENT OF THE COUNCIL AND THE COUNCIL OF THE CITY OF LEXINGTON, DAWSON COUNTY, NEBRASKA:

Section 1. This Ordinance is designated as "Chapter 8-A, Emergency Situations."

Section 2. Section 8-A-1 Definitions.

For the purpose of this Chapter, the following words and phrases shall have the meanings respectively given to them by this section.

A State of Emergency shall mean any unforseen combination of circumstances calling for immediate action, as may be determined by the City Manager, until such determination can be, approved and ratified or rejected by the next meeting of the City Council.

Section 3. Section 8-A-2 Authority of the City Manager.

The City Manageris hereby authorized and directed, whenever a state of emergency exists in the City of Lexington, Nebraska, to proclaim and publish rules and regulations which shall have the full force and effect of law, for the conduct and cooperation of persons, firms, corporations, and agencies. Such rules and regulations may affect the use of highways, streets, and alleys, and other public grounds, health care, police regulations, fire protection, and the general welfare and safety of the citizens of the City of Lexington, Nebraska. The City Manager may also request assistance from all organizations in the event of an emergency situation whether the organization is local, state, or national.

Section 4. Section 8-A-3 Duties of the City Manager.

The City Manager is hereby authorized and directed, to act as; or appoint or recommend for appointment a City volunteer emergency committee. The said committee shall direct the preparation and execution of emergency plans and volunteer emergency services in cooperation with the City Manager

the City Council, and other local, state, or national organizations interested in the welfare and safety of the citizens of the City of Lexington, Nebraska.

Section 5. Section 8-A-4 Duty to Obey.

It shall be unlawful to refuse or neglect to obey any such rules and regulations as proclaimed by the City Manager, or to refuse or to neglect to obey any order of the City Manager in connection therewith, or any call made upon any person, firm, corporation, and agency for aid in enforcing the same. Any person or persons found to so neglect or refuse to obey such a rule or regulation shall be guilty of a misdemeanor.

Section 6. Section 8-A-5 Persons Not Liable in Damages for Enforcement.

This Ordinance shall constitute an exercise of the City's governmental functions for the protection of the public peace, health, and safety. Neither the City nor any person, firm, corporation, or agency responding to the regulations lawfully proclaimed and published by the City Manager, or called upon to assist in enforcing the same shall be liable in a suit for damages in connection therewith.

Section 7. The penalty for the violation of any of the acts in this Ordinance shall be as provided by Section 1-7 of the Code.

Section 8. All parts of the Code in conflict with this Ordinance are hereby repealed.


