

AN ORDINANCE CREATING WATER EXTENSION DISTRICT NO. 8 OF THE CITY OF LEXINGTON, NEBRASKA; ESTABLISHING THE OUTER BOUNDARIES OF THE DISTRICT: DESIGNATING THE SIZE, LOCATION AND TERMINAL POINTS AND REFERRING TO THE PLANS AND SPECIFICATIONS AND ESTIMATE OF THE ENGINEER IN CONNECTION THEREWITH ON FILE WITH THE CITY CLERK; ORDERING THE ORDINANCE PUBLISHED IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA.

Section 1. The President and Council of the City of Lexington, Nebraska, hereby find and determine that it is necessary and advisable to extend the municipal water service to and beyond the existing system by the construction of water mains, and for the purpose of constructing said water mains there is hereby created Water Extension District No. 8 of the City.

Section 2. The outer boundaries of Water Extension District No. 8, in which it is proposed to make special assessments, shall include all the following described property, to-wit:

Lots Nine (9) and Ten (10), Block Three (3); Lots Nine (9) through Seventeen (17), inclusive, Block Four (4); Lots Nine (9) and Ten (10), Block Five (5); Lots Seventeen (17) through Twenty-seven (27), Block Six (6); and the South Four Hundred Eighty Three and Eight Tenths Feet (S 483.8') of Block Seven (7); all located in Woodward's Second Addition to the City of Lexington, Dawson County, Nebraska.

Section 3. The size, location and terminal points of the water mains in said District are as follows, to-wit:

Extension of a six inch (6") asbestos cement water main commencing at the existing line in Fifteenth Street at the intersection with Lake Street; thence North in Lake Street and West in Woodward Circle and terminating at a point on line with the North line of Lots Nine (9) and Ten (10), Block Three (3);

Extension of a six inch (6") asbestos cement water main commencing at the existing line in Fifteenth Street at the intersection with Hampton Street; thence North in Hampton Street and West in Grafton Drive and terminating at a point on line with the North line of Lots Nine (9) and Ten (10), Block Five (5);

Extension of a 10" asbestos cement water main commencing at the existing line in Fifteenth Street at the intersection with Erie Street; thence North in Erie Street and terminating at a point on line with the North line of Lot Eighteen (18), Block Three (3).

Section 4. It is hereby found and determined that none of the above property is located more than one mile from the city limits and the lots and lands included in Water Extension District No. 8 of Lexington, Nebraska, are located apart and outside of any area served or benefited by the existing water system.


Section 5. Reference is hereby made to the plans and specifications for the water extension which have been prepared by the City Engineer, by order of the President and Council of the City pursuant to a Resolution duly passed by the Council and which, together with the Engineer's estimate of the total cost of the proposed extension, have heretofore been filed with the City Clerk.

Section 6. The Engineer's estimate of the total cost of the project for Water Extension District No. 8 is as follows:
