AN ORDINANCE TO AMEND SECTION 16-41 OF THE LEXINGTON CITY CODE AND ESTABLISH A CITY SPEED LIMIT ON SOUTH BRIDGE STREET; TO REPEAL ORIGINAL SECTION 16-41 AND ALL OTHER ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR AN EFFECTIVE DATE AND FOR PUBLICATION IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, AS FOLLOWS:

SECTION 1. That Section 16-41 of the Lexington City Code is amended to read as follows:

Sec. 16-41 Same--Other Specific Speed Limits.

(a) The speed limit shall be thirty miles per hour on the following streets or parts of streets:

Bridge Street and Jackson Street, Maple to Fifth Street Fifth Street, Grant to Jefferson Grant Street, Fifth Street to Pacific Avenue Jefferson Street, Pacific Avenue to Fifth Street

(b) The speed limit shall be thirty-five miles per hour on the following streets or parts of streets:

Adams Street, from Drainage District No. 1 drainage ditch to Oak Street, and U.S. Highway 30 to the City Limits north of 20th Street

Pacific Avenue, 700 feet East of Monroe Street to 600 feet West of Adams Street

Taft Street, Pacific Avenue to 13th Street
East 13th Street, Fillmore East to the City Limits
West Walnut Street, Adams Street West to the City Limits
East Walnut Street, Bridge Street East to the City Limits

(c) The speed limit shall be forty miles per hour on the following street or part of street:
Bridge Street, Maple to Ash Street

- (d) The speed limit shall be forty-five miles per hour on the following streets or parts of streets: Pacific Avenue, East City Limits to 700 feet East of Monroe Street Pacific Avenue, 600 feet West of Adams to West City Limits Bridge Street, Ash Street to South City Limits
- (e) The speed limit shall be fifteen miles per hour in the school zone on the following street or parts of streets, while flashing lights are in operation: Walnut Street, Lincoln Street to Madison Street.

SECTION 2. That original Section 16-41 of the Lexington City Code, and all other ordinances or sections of ordinances in conflict herewith are hereby repealed;

SECTION 3. That this ordinance shall be published in pamphlet form and take effect as provided by law.
