ORDINANCE NO. 1989

AN ORDINANCE RELATING TO THE SCHEDULE OF RATES FOR THE SALE OF NATURAL GAS IN THE CITY OF LEXINGTON, NEBRASKA AND REPEALING ALL OTHER ORDINANCES IN CONFLICT WITH THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF  
THE CITY OF LEXINGTON, NEBRASKA

## SECTION 1.

Rates. The rates charged by K N Energy, Inc. (KNE or Company) for natural gas supplied to customers in the City of Lexington, Nebraska, hereinafter referred to as "City", unless otherwise approved by the Mayor and City Council shall not exceed the following, effective May 2, 1993:

## Customer Charge per Month:

Residential Service	\$5.00 per Meter*
Commercial Service	\$6.00 per Meter*

## Usage Charge - Residential:

First 10 Therms per month	\$0.608589 per Therm
Next 40 Therms per month	\$0.583589 per Therm
Next 450 Therms per month	\$0.483263 per Therm
Over 500 Therms per month	\$0.458263 per Therm

## Usage Charge - Commercial:

First 10 Therms per month	\$0.776176 per Therm
Next 40 Therms per month	\$0.751176 per Therm
Next 450 Therms per month	\$0.483263 per Therm
Over 500 Therms per month	\$0.458263 per Therm

\*Minimum Monthly Charge shall equal the customer charge.

Delayed Payment Charge: 5% on the first \$20.00 of bill, plus 2% on excess.

Bills will be rendered at monthly intervals.

## SECTION 2.

Ordinances governing natural gas rates and all other ordinances and parts of ordinances in conflict with this ordinance are hereby repealed. Provided, this ordinance shall not be construed so as to affect any rights, liabilities, or causes of action pending at the time when this ordinance takes effect with respect to the period prior to May 2, 1993.

SECTION 3.


When any municipality or other taxing authority imposes a franchise, occupation, business, sales, service, license, excise, privilege or similar tax of any kind on the Company, the amounts thereof, insofar as practical, shall be charged on a pro rata basis to all applicable customers receiving gas service from the Company within the municipality. This charge, in all cases, will be in addition to the regular charges for gas service. Where such tax is levied on a percentage of gross receipts, from customers or a class of customers, that percentage will be applied to each affected customer's bill, and the amount so computed will be added to such bill. The amount of the tax charged to each affected customer in each billing period will be shown as a separate item on the customer's bill and identified as such.



SECTION 4.

This ordinance shall be in full force and effect from and after its final passage and publication as required by law.
