ORDINANCE NO. 2013

AN ORDINANCE OF THE CITY OF LEXINGTON, NEBRASKA, CREATING STORM SEWER DISTRICT NO. 94-04; DECLARING THE ADVISABILITY AND NECESSITY OF CONSTRUCTING A STORM SEWER THEREIN; DESCRIBING SAID STORM SEWER AND THE LOCATION AND TERMINAL POINTS THEREOF; REFERRING TO PLANS, SPECIFICATIONS AND ESTIMATE OF COST FOR SAID IMPROVEMENTS.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Section 1. The Mayor and Council of the City of Lexington, Nebraska deem and hereby declare it advisable and necessary to build a storm sewer within the City as hereinafter provided and further find that said storm sewer will constitute a public improvement in said City which may properly be financed by issuance of the City's Storm Water Sewer District Bonds pursuant to Section 16-672.11, R.R.S. Neb. 1943.

Section 2. There is hereby created in the City of Lexington, Nebraska a storm sewer district to be known and designated as Storm Sewer District No. 94-04, the outer boundaries of which shall include all lots and lands directly abutting upon Thirteenth Street, as to the portion of such street described in Section 4 below, together with said portion of Thirteenth Street, all of said property being within the corporate limits of the City of Lexington, Nebraska, or within one mile beyond its corporate limits.

Section 3. The storm sewer shall be constructed in said District in accordance with plans and specifications prepared by Miller & Associates, special engineers for the City of Lexington, Nebraska. Reference is hereby made to said plans and specifications which have been filed with the City Clerk of the City of Lexington prior to the introduction and proposing of this Ordinance and which are hereby approved by the Mayor and City Council.

Section 4. The size, kind, location and terminal points of said storm sewer shall be as follows:

The storm sewer shall be located in the right-of-way of Thirteenth Street in the City of Lexington, commencing at the intersection of Thirteenth Street with the center line of Taft Street, and shall run thence west in the right-of-way of Thirteenth Street to a point located 873 feet west of the center line of Adams Street. Such storm sewer shall be constructed of reinforced concrete pipe and shall run in various sizes, as indicated in the plans and specifications, from beginning point to end point, including fifteen inch, eighteen inch, twenty-four inch, thirty inch, forty-two inch, and forty-eight inch.

Said storm sewer shall be constructed of cement concrete pipe and vitrified clay pipe or other material deemed suitable by the special engineer for the City.

Section 5. The special engineer's estimate of the total construction cost for improvements in said Storm Sewer District No. 94-04, which has been filed with the City Clerk prior to the introduction and proposing of this Ordinance, is \$ 393,252.00.


Section 6. To pay the costs of the improvements herein provided for, the Mayor and Council will, after such improvements have been completed and accepted by the City, cause to be issued the negotiable bonds of the City, all as provided by Sections 16-672.01 to 16-672.11, R.R.S. Neb. 1943.

Section 7. This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
