

RESOLUTION NO. R1656

A RESOLUTION SETTING ELECTRICAL RATES FOR ALL USER CLASSIFICATIONS.

WHEREAS, City Code Section 8-19 provides that the electrical rates shall be set by Resolution by the City Council for all user classifications,

NOW, THEREFORE, be it resolved by the City Council of Lexington, Nebraska that the following electrical rates for the following user classifications are established and shall be effective on January 1, 1980 and shall continue to be effective until revised.

Production Cost Adder Charge

Any production cost adder charged to the City by its supplier shall be assessed to all users at the same rate per KWH times a factor of 1.1.
