

RESOLUTION NO. 1711

A RESOLUTION SETTING ELECTRICAL RATES FOR ALL USER CLASSIFICATIONS, in accordance with Ordinance No. 1583.

WHEREAS, the City Council of Lexington, Nebraska, has passed Ordinance No. 1583, effective March 14, 1978, and,

WHEREAS, Ordinance No. 1583 provides that the electrical rates shall be set by resolution by the City Council for all user classifications.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF LEXINGTON, NEBRASKA, that the following electrical rates for the following user classifications are established and shall be effective January 1, 1982, and will be reflected on the billings received in February 1982. All rates shall continue to be effective until revised.

Production Cost Adder:

When the P.C.A. is charged to the City of Lexington by NPPD, the rate per kwh shall be multiplied by a factor of 1.10% for billings to customers of the City of Lexington.

When the P.C.A. is refunded to the City of Lexington by NPPD, the rate per kwh shall be multiplied by a factor of .90% for refunds to customers of the City of Lexington.
