

**RESOLUTION NO. 2015 – 18**

WHEREAS, Lexington City Code Sections 28-100, 28-232, and 28-439 authorize the City Council to establish by Resolution a schedule of rates and charges for electric service, water service, and sanitary sewer service.

BE IT THEREFORE RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, that the following utility rates are established and shall take effect January 1, 2016, to be reflected on billings following such date. That all other electric rates, water rates, and sanitary sewer rates previously established shall remain unchanged.

High Tension Service:

The High Tension rate shall be based upon a cost-plus calculation obtained from real-time metering. The rate shall include the actual cost of wholesale electricity purchased plus a percentage added to cover the required electric utility margin. The High Tension rate will be calculated, charged, and managed by the City Manager.

**Section 2. Water Rates**

Residential Metered:	The first 5,000 gallons	\$16.75 monthly minimum
	> 5,000 gallons	\$0.90 per 1,000 gallons
Residential Flat Rate:	\$24.00 per dwelling unit per month	
Commercial Metered:	The first 5,000 gallons	\$16.75 monthly minimum
	> 5,000 gallons	\$0.90 per 1,000 gallons

Multi-unit Service Fee: \$10.00 per dwelling/commercial unit, where more than one dwelling/commercial unit is served by a single metered service.

Industrial Metered: \$0.2905 per 1,000 gallons

Automated Meter Reading Adder: \$1.00 per month per water meter, or unmetered service.

**Section 3. Sanitary Sewer Rates**

Flat Rate Residential: \$25.00 per month.

Flat Rate Commercial: \$25.00 per month

Commercial Metered: \$2.30 per 1,000 gallons  
\$17.00 minimum
