CITY HALL LEXINGTON, NEBRASKA

The Mayor and Council of the City of Lexington, Dawson County, Nebraska, met in regular special session in the City Hall at 8.00 o'clock P. M., on June 1, 1937
Mayor Kjar presided and
City Clerk Olsson recorded
the proceedings of this meeting.

The Mayor instructed the Clerk to call the roll. The Clerk called the roll and the following Councilmen were present: Gillan, Morganson, Morgan, Berrett, Evans.

Absent: Councilman Hagadone.

Whereupon the Mayor announced that the introduction of ordinances was now in order, and the matter now coming before the Mayor and Council was the passage and approval of Ordinance No. 330 of the City of Lexington, Nebraska.

This ordinance was introduced by Councilman Evans and is in words and figures as follows, to wit:

ORDINANCE NO. 330

An ordinance to amend Section No. 2, of Ordinance No. 32, of the City of Lexington, Nebraska.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF
THE CITY OF LEXINGTON, NEBRASKA:

Section 1. That Section No. 2 of Ordinance No. 32 of the City of Lexington, Nebraska, which was passed and approved June 11, 1906, be amended to read as follows:

"Section 2. That all sidewalks outside of the business district of said City of Lexington shall be laid two feet from the lot line, and the space between the lot line and the sidewalk shall be graded up to the level of the sidewalk. Provided, however, that on any street which is paved or curbed, guttered and graveled, said sidewalk may be laid next to and abutting the curb in any one block, by agreement of all of the property owners owning property abutting on said street in said block; and where said sidewalk is to be laid next to the curb as herein provided, a written agreement shall be executed by all of the owners of property abutting on said street in said block, agreeing to the construction of such sidewalk along the curb in said block, which agreement shall be filed with the City Clerk,

and the Council shall, by motion, if such agreement is properly executed and filed, authorize the construction of the same as herein provided and subject to the further provisions of this ordinance."

Section 2. Said original Section No. 2 of Ordinance No. 32 is hereby repealed.
