## ORDINANCE NO. 622.

AN ORDINANCE DESIGNATING A CHANGE IN THE LOCATION OF AN ALLEY BETWEEN MESA ADDITION AND MESA ADDITION NO 2, AND KELLY'S ADDITION TO THE CITY OF LEXINGTON, NEBRASKA; ACCEPTING DEEDS FOR THE NEW ALLEY AND APPROVING THE DEED OF VACATION AND VACATING THE EXISTING ALLEY.

BE IT ORDAINED BY THE PRESIDENT OF THE COUNCIL AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA:

Deeds are hereby accepted from Harold A. Howell and Nadine B. Howell, and William Britton and Hazel F. Britton to the following described real estate to be used as an alley for Mesa Addition, Mesa Addition No. 2, and Kelly's Addition to the City of Lexington, Nebraska:

> Commencing at the Northeast corner of Lot Four (4)
> Mesa Addition to the City of Lexington, Dawson County,
> Nebraska, and thence East Eighty-eight (88) feet to
> the West line of Tract H, Suburban Addition to the City
> of Lexington, Nebraska; thence North along said West
> line of Tract H Eight Hundred and Forty-six (846) feet
> to the South line of 20th Street; thence West Twenty
> (20) feet along the South line of 20th Street; thence South along a line parallel with the West line of Tract "H", Eight Hundred and Twenty-six (826) feet to a point Twenty (20) feet North of the North line of Lot Five (5) Mesa Addition; thence West Sixty-eight (68) feet; thence South Twenty (20) feet to the place of beginning.

Section 2. Said above described real estate is hereby designated as an alley to serve Mesa Addition, Mesa Addition No. 2, and Kelly's Addition to the City of Lexington, Nebraska.

Section 3. Deed of Vacation of the old alley, formerly serving Mesa Addition and Mesa Addition No. 2 and described as follows is hereby approved:

Commencing at the Southeast corner of Lot Six (6), Mesa Addition to the City of Lexington, and thence East Twenty (20) feet; thence North Eight Hundred and Twenty-six (826) feet to the South line of 20th Street; thence West Twenty (20) feet to the Northeast corner of Lot Seven (7) Mesa Addition No. 2; thence South Eight Hundred and Twenty-six (826) feet to the place of beginning of beginning.

Said alley is hereby vacated with the reservation by the City of an easement for the purpose of installation, repair and maintenance of overhead or underground Electric Service lines, poles and other necessary equipment incidental thereto.
