ORDINANCE NO. 762

AN ORDINANCE PROVIDING FOR THE APPOINTMENT OF A CIVIL SERVICE COMMISSION IN THE CITY OF LEXINGTON, NEBRASKA TO REGULATE THE EMPLOYMENT OF PAID MEMBERS OF THE POLICE AND FIRE DEPARTMENTS OF SAID CITY: INCORPORATING BY REFERENCE SO FAR AS IS APPLICABLE SECTIONS 19-1801 to 19-1823 OF THE REISSUE REVISED STATUTES OF THE STATE OF NEBRASKA, 1943, AND AMENDMENTS THERETO AS PROVIDED IN LEGISLATIVE BILL NO. 305 ENACTED WITH EMERGENCY CLAUSE BY THE SIXTY-EIGHTH SESSION OF THE LEGISLATURE OF NEBRASKA: AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH.

WHEREAS, the sixty-eighth session of the legislature of Nebraska passed with the emergency clause legislative Bill No. 305 and the same has been approved, and which supplements Sections 19-1801 to 19-1823 of the reissue Revised Statutes of the State of Nebraska, 1943, and which makes it mandatory upon every city in Nebraska having a population of over 5,000 inhabitants which has paid members in it's police or fire departments to create a Civil Service Commission and to enact appropriate legislation for appointment of members thereof.


NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT OF THE COUNCIL AND THE COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA;

SECTION ONE: That there is hereby created within the City of Lexington, Nebraska a Civil Service Commission composed of three members to be appointed by the City Manager. The term of office of the commissioners shall be six years except members of the first commission of which one member shall be appointed for a term of two years, one for a term of four years and one for a term of six years.

SECTION TWO: That Sections 19-1801 to 19-1823 of the Reissue Revised Statutes of the State of Nebraska, 1943, and amendments thereto as set forth in Legislative Bill No. 305 duly enacted with emergency clause by the Sixty-Eighth Session of the Legislature of Nebraska shall so far as applicable be a part of this Ordinance and by reference incorporated herein.

SECTION THREE: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby repealed.
