AN ORDINANCE TO AMEND SECTION 28-23 TO PROVIDE SPECIAL USE PERMITS FOR TEMPORARY COMMERCIAL AND INDUSTRIAL USES; TO REPEAL ORIGINAL SECTION 28-23 AND ALL ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT THEREWITH: TO PROVIDE FOR AN EFFECTIVE DATE AND PUBLICATION IN PAMPHLET FORM.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF LEXINGTON, NEBRASKA, AS FOLLOWS:

Section 1. That Section 28-23 of the Lexington City Code is hereby amended to read as follows:

Section 28-23. Special Uses Zone Districts.
