CALL TO ORDER: The meeting was called to order by Chair Heineman who informed the public that the Open Meetings Act is posted in the Meeting Room at the Lexington City Hall, located at 406 East 7th Street, Lexington, Nebraska.

REZONING APPLICATION: Heineman opened a public hearing in which Brecks presented an Application for Rezoning by Jose Gomez Aguirre for property located at 211 West Cedar from R-1 Single Family Residential to R-2 Two Family Residential. He reported that Mr. Gomez Aguirre plans to renovate the dwelling on the property into a duplex. He noted preliminary inspections have been completed but no formal plans have been finalized contingent upon the rezoning change. A draft development agreement was presented for commission review. The public hearing was closed. Following discussion, Moved by Smith, seconded by McFarland, to recommend to the City Council approval of the Application for Rezoning by Jose Gomez Aguirre as presented. Roll call.
