A Regular Meeting of the Lexington Planning Commission was held Wednesday, December 4, 2024, in the Council Chambers at Lexington City Hall, 406 East 7th Street, Lexington, Nebraska, at 5:30 p.m. Commissioners present were Sadie Worthing, Cameron Smith, Jeremy Kaiser, Curtis Roemmich, Kristi Moyer, and Jeff Tappan.
