Director's Report – Pepplitsch discussed the status of a program agreement with NDOR/UPRR for the East Lexington Viaduct project. He indicated that the City of Lexington is currently drafting an interlocal agreement between the City and Dawson County for administration of the project; as will be required before NDOR will draft a final program agreement for the project. He estimated that preliminary design and environmental review for the project will begin by the end of the year.
