Motion was made by Hagan and seconded by Stewart to utilize the budget document as an audit waiver for the State Auditor's requirements. Aye: Salem, Miller, Stewart, Hagan, Tomasek. Nay: None. Absent: Bauer. Motion carried.

Director's Report – as of August 30, 2010 we have \$236,861.14 and an additional \$43,094.84 that will be deposited on September 15, 2010. Motion was made by Salem and seconded by Hagan to accept the financial report. Aye: Stewart, Miller, Hagan, Salem, Tomasek. Nay: None. Absent: Bauer. Motion carried.

Citizen's comments: City Manage Joe Pepplitsch reported that the interlocal agreement between the City of Lexington and Dawson County has been sent to the state and is expecting the funding agreement soon. There being no further business, the meeting was adjourned at 5:20 p.m. The next regular meeting is scheduled for Thursday, October 14, 2010, pending any action that needs to be taken.
